MINUTES OF THE DISCIPLINARY PROCESS REVIEW COMMITTEE August 23, 2007

Chairman Lawrence Anderson, M.D., called the meeting to order at 10:00 a.m. Other members present were Roberta Kalafut, D.O, Amanullah Khan, M.D., Melinda McMichael, M.D., Irwin E. Zeitler, Jr., D.O., and Patricia S. Blackwell. Melinda S. Fredricks arrived late at approximately 11:20, a.m. Committee Members Margaret C. McNeese, M.D. and Annette P. Raggette were not present.

Also present was Executive Director Donald Patrick, M.D., J.D., Jane McFarland, Chief of Staff, and Mari Robinson, Director of Enforcement, and various other staff.

Dr. Kalafut moved and Ms. Blackwell seconded, and the motion passed at 10:01 a.m. for private consultation and advice of counsel concerning pending or contemplated litigation, deliberations concerning licensure applications, and/or possible disciplinary actions under the authority of the Open Meetings Act, Government Code Sec. 551.071; and the Medical Practice Act, TEXAS OCCUPATIONS CODE, ANNOTATED, Sections 152.009, 155,058, 160.006, and 164.071; and the Medical Practice Act, TEXAS OCCUPATIONS CODE, ANNOTATED, Sections 152.009, 160.006, 164,007, and 164.203; and the Attorney Generals Opinion No. H0484. Ms. Blackwell moved and Ms. Frederick seconded that the appeal of item 2.B.2. File #07-3252 be granted. Motion carried.

Ms. Blackwell moved and Dr. Khan seconded that the appeal of the remaining items listed under 2.B., be denied. Motion carried.
