

# Texas Medical Radiologic Technology Board

## LICENSURE COMMITTEE

### MEETING MINUTES

February 15, 2019

The meeting was called to order at 9:32 a.m. by Chair, Jennifer C. Flanagan, MRT. Committee members present were Nicholas M. Beckmann, M.D., Anthony “Tony” Jaso, Carol Waddell, MRT, and Linda Brown.

#### **Agenda Item 2 - Applicants appearing concerning eligibility.**

**Applicant #1963** reappeared before the Committee after previously appearing in March 2017 due to his criminal history. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Ms. Waddell moved that the committee recommend to the full Board that that the applicant be granted a Limited Medical Radiologic Technologist license. Dr. Beckmann seconded the motion. All voted in favor. The motion passed.**

**Applicant #2279** appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Mr. Jaso moved that the committee recommend to the full Board that the applicant be granted a Medical Radiologic Technologist certificate. Dr. Beckmann seconded the motion. All voted in favor. The motion passed.**

**Applicant #2278** appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Ms. Waddell moved that the applicant be placed on the Non-Certified Radiologic Technician Registry under a public Agreed Order subject to the following terms and conditions:**

- **Applicant shall comply with all requirements of the probationary program with Johnson County, Texas.**
- **The order shall auto terminate upon demonstration of successful completion of all the terms of the order.**

This recommendation is due to the applicant’s criminal history and current probationary status with Johnson County, Texas. **Dr. Beckmann seconded the motion. All voted in favor. The motion passed.**

**Applicant #2232** appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Dr. Beckmann moved that the applicant be granted a Medical Radiologic Technologist certificate under a public Agreed Order subject to the following terms and conditions:**

- **Complete deficient Continuing Education required for licensure**
- **Work in a monitored setting approved by the Board for a period of six months**
- **Upon completion of the six months have the approved supervising practitioner provide a final evaluation of performance.**
- **The order shall auto terminate upon demonstration of successful completion of all the terms of the order.**

This recommendation is due to the applicant's disciplinary history and unlicensed practice as a Medical Radiologic Technologist in Texas. **Ms. Waddell seconded the motion. All voted in favor. The motion passed.**

**Applicant #2284** appeared before the Committee to appeal the Executive Director's determination. The applicant presented a brief summary and the Committee members asked questions.

**Dr. Beckmann moved, and Ms. Waddell seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Applicant #2284. The motion passed.** Dr. Beckmann announced that the meeting would be closed for deliberations at 10:12 a.m. under the authority of Texas Government Code Chapter 551.071, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

**The Executive Session ended at 10:37 a.m.**

**Applicant #2284 Continued**

**Dr. Beckmann moved that the committee recommend to the full Board that the applicant's appeal of the Executive Director's decision be granted and that the applicant be issued a Supervised Temporary Medical Radiologic Technologist certificate under the following new terms and conditions:**

- **Applicant will complete a minimum of fifty hours working in a board approved supervised setting within a period of ninety days.**
- **Applicant shall have Midwestern University provide a copy of her official transcript to show applicant has completed the required amount of CEUs.**
- **Upon successful completion of all requirements Applicant can be issued a full medical radiologic certificate.**

This recommendation is due to the applicant's time out of active practice as a Medical Radiologic Technologist. **Ms. Waddell seconded the motion. All voted in favor. The motion passed.**

**Applicant #2291** appeared before the Committee to appeal the Executive Director's determination. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Dr. Beckmann moved that the applicant's appeal be granted and the applicant be issued a Medical Radiology certificate under a public Agreed Order subject to the following terms and conditions:**

- **The applicant work in a monitored setting approved by the Board for a minimum of 20 hours a week for 20 weeks.**
- **A final evaluation of the applicant's performance will be provided to the Board upon completion of the 20 weeks.**
- **The order shall auto terminate upon demonstration of successful completion of all the terms of the order.**

This recommendation is due to the applicant's failure to meet active practice. **Mr. Jaso seconded the motion. All voted in favor. The motion passed.**

**Agenda Item 3 - Proposed licensure agreed orders or remedial plans offered by the Executive Director.** Ms. Johnston reported on **5 Remedial Plans and 6 Agreed Orders** offered by the Executive Director and accepted by applicants. **Dr. Beckmann moved that the 5 Remedial Plans and 6 Agreed Orders be approved. Ms. Waddell seconded. All voted in favor. The motion passed.**

**Agenda Item 4 –** There being no further business, **Mr. Jaso moved that the meeting be adjourned. Ms. Waddell seconded. All voted in favor.** The meeting was adjourned at **11:20 a.m.**
