BOARD MEETING FRIDAY, SEPTEMBER 18, 2020 VIDEO CONFERENCE AUSTIN, TEXAS

The Texas State Board of Acupuncture Examiners is posting the following Notice per Texas Government Code Sec. 551.041, 551.045, and 551.125.

On March 13, 2020, the Governor of Texas certified COVID-19 as posing an imminent threat of disaster to the public health and safety and declared a state of disaster in all counties of Texas. Therefore, an emergency or public necessity exists within the meaning of Texas Government Code Section 551.045. Further, travel limitations necessary to mitigate the risk of exposure to COVID-19 render the convening at one location of a quorum of the Acupuncture Examiners Board, an advisory board to the Medical Board, difficult or impossible.

Additionally, there is an urgent public necessity for the Acupuncture Examiners Board to carry out the functions and duties of the Board, pursuant to Tex. Occ. Code Sec. 205.101, including, but not limited to, licensing acupuncturists, who are needed to provide patient care and ensure adequate staffing at healthcare facilities. In addition, there are a number of disciplinary actions pending that need to be considered and reviewed for possible Board action in order for the Board to effectively and efficiently resolve such pending matters and monitor those licensees.

Accordingly, the meeting will proceed by video conference, as allowed under Texas Government Code, Sec. 551.125(b). The public and members may attend by video conference. The meeting link is:
