After discussion, Mr. Cline moved, Mr. Graham seconded, and the motion passed to approve the rule review and proposed amendments with the following changes:

- a. <u>183.2. Definitions</u>. Add a Biomedicine Module.
- b. <u>183.4. Licensure</u>. Revise three attempts to five attempts, each component of the full National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM) examination.
- c. <u>183.10. Patient Records</u>. Revise vital signs to include body temperature, pulse or heart rate, and blood pressure upon initial presentation of the patient, and those vital signs as deemed appropriate by the practitioner for follow-up treatment.
- d. <u>183.20. Continuing Acupuncture Education.</u> Add (5) Effective for licensees applying for renewal of their licensees on or after November 30, 2010, at least one hour of biomedicine.

Agenda item #14, Consideration and Approval of the February 1, 2008 Board Meeting Minutes. After discussion, Mr. Garcia moved, Mr. Graham seconded, and the motion passed to approve the February 1, 2008 Board Meeting Minutes and action items.
