EDUCATION COMMITTEE MEETING MINUTES

February 1, 2019

The meeting was called to order at **9:36 a.m.** by Mr. Cline, L.Ac., Chair. Committee members present were Allen Cline, L.Ac., Donna Guthery, L.Ac. and Claudine Vass.

Agenda Item 2 – Discussion, recommendation, and possible action regarding requests to become approved providers. There were none.

Agenda Item 3 – Report from staff of renewal of approved providers. There were none.

Agenda Item 4 - Report from staff of continuing acupuncture education courses approved. Ms. Johnston presented a report on the courses that were approved by staff.

Agenda Item 5 - Discussion, recommendation, and possible action regarding requests for approval of continuing acupuncture education courses.

Ms. Guthery moved to recommend to the full board that the Mayan Traditional Healing with the 5 Elements of Chinese Medicine course reviewed by this committee, offered by Acupuncturists Without Borders, be approved based on the NCCAOM amounts of 26 PDA points and that they be listed as part of the minutes of this committee. Ms. Webb seconded. All voted in favor and the motion passed.

Ms. Webb moved to recommend to the full board that the Jing Module Chinese Face Reading course reviewed by this committee, offered by Sherron Hughes, be denied. This denial is based on the instructor's qualifications not meeting the requirements under Board rule 183.20(t) and course content not being relevant to the practice of acupuncture. All voted in favor and the motion passed.
