## TEXAS MEDICAL BOARD MINUTES OF THE DISCIPLINARY PROCESS REVIEW COMMITTEE December 11, 2008

Chairman Larry Price, D.O., called the meeting to order at 9:50 a.m. Other members present were David Baucom, Melinda McMichael, M.D., Margaret C. McNeese, M.D., Charles Oswalt, M.D., Allan Shulkin, M.D., and George Willeford, III, M.D. Committee Members Patricia S. Blackwell, Amanullah Khan, and Annette P. Raggette were not present. Committee Member Manuel Guajardo, M.D. arrived at 12:37 p.m.

Also present was Mari Robinson, Director of Enforcement/Interim Executive Director, and various other staff.

Dr. Oswalt moved, and Dr. Shulkin seconded; the motion passed at 9:52 a.m. to go into Executive Session deliberations concerning disciplinary action, investigative information, peer review information, and rehabilitation orders under the authority of The Medical Practice Act Sections 152.009, 160.006 through .008, 164.007(c), and 164.202 & .203, Occupations Code. Open session resumed at 12:03 p.m. and it was announced that no action was taken during executive session. A certified agenda of the executive session was made.

Dr. McMichael moved, and Dr. Oswalt seconded that the appeal of Item 2.A.i., Log #08-3619 be granted and that a new panel review be obtained to evaluate the original SOC issue in this case; also, the appeal documentation submitted by the Complainant and the issue of possible unprofessional conduct. Motion carried.

Dr. McMichael moved, and Dr. McNeese seconded that the appointments and the removal of members to and from the Expert Physician Panel be accepted as noted in the attachment. Motion carried.

Dr. Willeford moved, and Dr. Oswalt seconded; the motion passed at 1:02 p.m. to go into Executive Session deliberations concerning disciplinary action, investigative information, peer review information, and rehabilitation orders under the authority of The Medical Practice Act Sections 152.009, 160.006 through .008, 164.007(c), and 164.202 & .203, Occupations Code.

Dr. McMichael moved, and Dr. Oswalt seconded that the appeal of Item 2.B., Log #08-1722 be granted and that an investigation be opened. Motion carried.

Mr. Baucom moved, and Dr. McNeese seconded that the appeal of Item 2.B., Log #08-6188 be denied and that a custom letter be sent to the Complainant notifying them of the actions that the Respondent had taken with this particular employee. Motion carried.

Dr. Oswalt moved, and Dr. McMichael seconded that all other appeals not specifically granted above be denied. Motion carried.

Dr. Oswalt moved, and Mr. Baucom seconded that all waivers on Agenda Item 6 be granted. Motion carried.

Discussion continued on Agenda Item #8. Review, discussion, and possible action regarding selected files and cases.

Dr. McMichael moved, and Dr. McNeese seconded that Log #08-2898 be forwarded to an ISC. Motion carried.

Dr. Oswalt moved, and Dr. Guajardo seconded that Log #08-3461 be forwarded to an ISC or that the case be resolved via Administrative Penalty procedures. Motion carried.

Dr. Shulkin moved, and Dr. Oswalt seconded that Log #08-3572 be handled via a waiver disciplinary order and the Respondent write a letter of apology to the Complainant in this case. Once the Respondent provides proof that this letter was delivered to the Complainant, this waiver will terminate. Motion carried.

Mr. Baucom moved, and Dr. Oswalt seconded that Log #08-3654 be closed and that a custom letter be sent to the Respondent admonishing them of the importance of vigilant surgical procedures in order to avoid circumstances that led to the initiation of this complaint. Motion carried.

Dr. McNeese moved, and Dr. Oswalt seconded that Log #08-3799 be forwarded to an ISC. Motion carried.

Dr. McMichael moved, and Dr. Oswalt seconded that the investigations and cases reviewed by the committee be resolved as noted and that they be listed along with each resolution as part of the minutes of this Committee. Motion carried.
