**Licensure Committee Proposed Non-Public Non-Disciplinary Rehabilitation Order**  
August 20, 2009

**Applicant #836** appeared with counsel, before the Committee, in executive session, on appeal of an order proposed by the Executive Director. In open session, **Ms. Southard moved to recommend to the full Board that the applicant be granted a Physician in Training permit under the non-public, non-disciplinary rehabilitation order that was previously proposed by the Executive Director.** This recommendation is due to applicants mental condition that could potentially render applicant unable to safely practice medicine. Factors contributing to this recommendation include that applicant was diagnosed with Major Depressive Dis order that affected applicants academic performance and required nearly a year-long leave of absence. **Dr. Benavides seconded the motion.**  
**All voted in favor. The motion passed.**
