LICENSURE COMMITTEE MEETING MINUTES

December 14, 2012

The meeting was called to order at 8:31 a.m. by the Chair, Teralea Jones, PA-C. Committee members present were Margaret Bentley and Richard Rahr, Ed.D, PA-C.

Agenda Item 2 Discussion, recommendation, and possible action regarding licensure applicants referred to the Licensure Committee by the Executive Director for determination of eligibility of licensure.

Applicant #1326 appeared before the Committee after referral by the Executive Director. Following discussion, **Dr. Rahr moved to recommend to the full Board that the applicant be** granted a Texas physician assistant license Ms. Bentley seconded the motion. All voted in favor. The motion passed.

Applicant #1336 appeared before the Committee after referral by the Executive Director. Following discussion, **Dr. Rahr moved to recommend to the full Board that a decision be deferred so the applicant may undergo fingerprinting through the FBI. Upon receipt of the fingerprint results the applicant will need to reappear before the committee.** This recommendation is due to the applicants criminal history, specifically a juvenile felony conviction for delinquent conduct in 1987. Ms. Bentley seconded the motion. All voted in favor and the motion passed.

The committee directed staff to require all Physician Assistant applicants with criminal history, who are appearing before the committee, to undergo fingerprinting.

Applicant #1338 appeared before the Committee after referral by the Executive Director. Following discussion, **Dr. Rahr moved to recommend to the full Board that the applicant be** granted a Texas physician assistant license. Ms. Bentley seconded the motion. All voted in favor. The motion passed. Applicant #1322 appeared before the Committee, with counsel, after referral by the Executive Director. Following discussion, Ms. Bentley moved to recommend to the full Board that the applicant be granted a Texas physician assistant license. Dr. Rahr seconded the motion. All voted in favor. The motion passed.

Applicant #1314 appeared before the Committee after referral by the Executive Director. Following discussion, **Dr. Rahr moved to recommend to the full Board that the applicant be** granted a Texas physician assistant license. Ms. Bentley seconded the motion. All voted in favor. The motion passed.

Agenda Item 3- Discussion, recommendation, and possible action regarding review of physician assistant applications for permanent licensure. There were 172 applicants and 5 relicensure applicants who met all requirements to be considered for permanent licensure by the full Board. Dr. Rahr moved to recommend to the full board that all 172 applicants and 5 relicensure applicants be approved for permanent licensure. Ms. Bentley seconded the motion. All voted in favor and the motion passed.

Dr. Rahr requested discussion regarding the criminal history of applicant #1307, who declined to appear, which included a felony conviction for unarmed burglary of a bank, and the consequences of licensing someone who has been convicted of a felony. The committee directed staff to have the applicant submit fingerprints should the applicant appear at the next meeting.

Agenda Item 4 Discussion, recommendation and possible action regarding proposed orders offered by the Executive Director. The Committee reviewed one order offered by the Executive Director and accepted by applicants. Ms. Bentley moved to recommend to the full Board that the order be approved. Dr. Rahr seconded. All voted in favor and the motion passed

Agenda Item 5 - Report on physician assistant licensure process statistics Ms. Knight reported that the 594 new PA licenses issued in fiscal year in 2012 were completed in an average of and 33 days.
