



ANNUAL REPORT OF NON-FINANCIAL DATA DECEMBER 2018

Texas Medical Board (TMB) Report of Investigations Pending Over One-Year For the Fiscal Year Ended 8/31/18

Under the requirements of SB 104 (78R), TMB is required to submit an annual report of "information regarding any investigations that remain pending after one year, including the reasons the investigations remain pending." (VTCA, OCCUPATIONS CODE, §153.056).

In preparing this data, TMB has defined "pending investigations" as all investigations that were opened on or before August 31, 2017 that did not have a final disposition (either dismissed or a final Board Order) by August 31, 2018.

TOTAL PENDING INVESTIGATIONS

As of filed date August 31, 2018, there were 291 investigations in the agency that had been open for at least one year.

OPEN INVESTIGATIONS IN INVESTIGATION DEPARTMENT

Of the 291 investigations over one-year old, 86 were still pending in the Investigations Department.

- **Forty-six** investigations involved criminal charges or charges by another state board or agency and are on hold pending the outcome of a trial or court proceeding.
- **Eighteen** investigations are on hold pending notification of TXPHP resolution.
- **Twelve** were referred to the Litigation Department after September 1, 2018.
- **Six** were dismissed by the Board after September 1, 2018.
- **Two** are scheduled to be heard by the Board in March 2019.
- One is on hold pending the outcome of the respondent's lawsuit against the TMB.
- One remains open pending necessary records or additional evidence.

OPEN INVESTIGATIONS IN LITIGATION DEPARTMENT

51 of the remaining 205 investigations transferred to the Litigation Department were merged into 16 cases. The mergers were done to maximize the efficient use of agency time and resources and present the strongest legal case. The merger of the investigations resulted in a total of 170 cases. (Table 2 lists the mergers of the investigations into cases).

OPEN CASES IN LITIGATION DEPARTMENT

• Of the 170 total cases, **seventy-four** were closed by Board action after September 1, 2018, either via a Board Order, Remedial Plan or dismissal. **Nine** cases are on hold pending notification of TXPHP resolution. **Four** cases are undergoing secondary legal review. **Two** cases involved criminal charges and are on hold pending the outcome or sentencing of the trial. **Two** cases are being recommended for dismissal and are scheduled to be presented to the Board in February 2019. **One** case received a signed Agreed Order that is scheduled to be presented to the Board in March 2019.


- There are <u>fifty-six</u> cases pending action at SOAH (includes either awaiting the hearing date or awaiting the issuance of the Proposal for Decision by the Administrative Law Judge.)
- There are 22 cases still in the agency hearings Informal Settlement Conference (ISC) process:
 - o For <u>eighteen</u> of these cases, the agency is either still negotiating with the physician to obtain an Agreed Order or is preparing the formal complaint for filing at SOAH.
 - o For **three** of these cases an ISC hearing date has been set or the ISC is pending.
 - For <u>one</u> of these cases, the licensee has been temporarily restricted by the Board following the ISC.



Texas Medical Board (TMB) Report of Investigations Pending Over Six Months Without Informal Hearing For the Fiscal Year Ended 8/31/18

Under the requirements of SB 419 (79R), TMB is required to submit an annual report of "information about any complaint for which notice is required under Subsection (a), including the reason for failing to schedule the informal meeting before the 180-day deadline." (VTCA, OCCUPATIONS CODE, §164.0036).

In preparing this data, TMB has defined "before the 180-day deadline" as all investigations that were opened on or before March 3, 2018 that did not have an informal meeting (either scheduled or held) by August 31, 2018. This addendum excludes investigations opened prior to September 1, 2017.


TOTAL PENDING INVESTIGATIONS

As of August 31, 2018 there were 157 investigations in the agency that had been open for at least six months without an informal meeting.

- **Forty-nine** investigations were dismissed by the Board after August 31, 2018.
- **Forty-two** involved criminal charges or charges by another state board or agency and are on hold pending the outcome of a trial or court proceeding.
- **Thirty-eight** were referred to the Litigation Department or scheduled for an informal hearing after August 31, 2018.
- **Ten** remain open due to delays in obtaining pertinent documents which have now been received.
- Six remain open as pertinent documents have been unavailable despite repeated requests.
- **Four** are scheduled to be heard by the Board in March 2019.
- Three were delayed due to an administrative oversight.
- **Two** were closed by Board action after August 31, 2018.
- **Two** remain open as respondent refused to cooperate during course of the investigation.
- One remains open due to unavoidable delays in obtaining an expert panel.

Texas Medical Board (TMB) Complaints Received and Complaint Disposition By Type Fiscal Year '18

Under the requirements of SB 104 (78R), TMB is required to submit a report each fiscal year that "provides aggregate information about all complaints received by the board categorized by type of complaint, including administrative, quality of care, medical error, substance abuse, other criminal behavior, and the disposition of those complaints by category." (VTCA, OCCUPATIONS CODE §154.002). This report includes all complaints that were conducted under the provisions of SB 104 for licensed physicians and have been resolved from September 1, 2017 through August 31, 2018.

In preparing this report, the Board identified eight categories of complaints (including the five listed above) and their final dispositions. Within each of the eight complaint categories is a list of the associated violations (as provided by the Medical Practice Act) that fall within that category. This report includes only the <u>primary</u> allegation for each complaint at the time of the board action concerning the complaint, and does not include secondary allegations of violations that may be associated with a complaint. For dismissed cases, this is determined by the primary allegation at the time the investigation was filed. For cases with action, this is determined by the primary violation identified as the reason for the action.
