



TEXAS PHYSICIAN ASSISTANT BOARD

LICENSURE COMMITTEE MEETING MINUTES

March 24, 2017

The meeting was called to order at 9:02 a.m. by Chair, Teralea Jones, PA-C. Committee members present were Karrie L. Crosby, PA-C, Raymond B. Rush and Victor Shen-Pou Ho, M.D.

Agenda Item 2 – Applicants appearing concerning eligibility.

Applicant #2005 appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, Mr. Rush moved to recommend to the full Board that the applicant receive a private referral to the Texas Physician Health Program for evaluation and compliance with all requirements and recommendations by the program. Upon resolution with the PHP, the applicant may be granted a Texas physician assistant supervised temporary license with an expiration date that will allow the applicant to obtain at least 20 hours a week supervised practice for at least 40 weeks in a 12-month period subject to the following restrictions: that the applicant work full time, only in an academic or group practice setting that has been approved by the Executive Director that provides continuous full-time, on-site physician supervision by single Texas licensed physician that has been approved by the Executive Director; the applicant be restricted from prescribing controlled substances; the supervising physician shall submit monthly reports for the first six months and then quarterly reports thereafter, regarding the applicant's work performance; the supervising physician shall submit, one month prior to the temporary license expiring, a log showing time worked regarding the applicant's work performance. The applicant will be required to reappear before the Licensure Committee at the end of 12-month period. If the applicant's supervised temporary license expires prior to the

applicant's appearance before the Committee, board staff is directed to extend the supervised temporary license to accommodate the applicant. Factors contributing to this recommendation include the applicant being censured by the NCCPA, the applicant's intemperate use of alcohol that could endanger the public and time out of practice as a physician assistant. **Mr. Rush seconded the motion. All voted in favor. The motion passed.**

Agenda Item 3 - Discussion, recommendation, and possible action regarding review of Physician Assistant applications to be licensed - Ms. Johnston reported there were **233** regular applicants and **8** relicensure applicants who met all requirements to be considered for permanent licensure by the full Board. **Ms. Crosby moved to recommend to the full board that all 233 regular applicants and 8 relicensure applicants be approved for permanent licensure. Mr. Rush seconded the motion. All voted in favor and the motion passed.**

Agenda Item 4 – Proposed Orders Offered by the Executive Director – Ms. Johnston reported on **1** physician assistant agreed order offered by the Executive Director and accepted by the applicant. **Ms. Crosby moved to recommend to the full Board that the agreed order be approved. Mr. Rush seconded. All voted in favor. The motion passed.**

Mr. Rush directed staff to include a copy of the Executive Director Summary in orders that have been recommended by the ED and approved by the Licensure Committee Chair and accepted by the applicant.

Agenda Item 5 - Report on physician assistant licensure process statistics – Ms. Johnston reported that 205 physician assistant licenses were issued in the 3rd Quarter of Fiscal Year 2016 in an average of 30 days. In the 3rd Quarter of Fiscal Year 2017, as of 3/14/2017, 228 physician assistant licenses were issued in an average of 31 days.

Mr. Cooper discussed the issue of Physician Assistant application processing time and the information being provided to physician assistant applicants.

Agenda Item 6 - Discussion, recommendation, and possible action regarding staff issuance of permanent physician assistant licenses. The discussion was referred to the full Board discussion under Agenda Item 8.

Agenda Item 7 - There being no further business, Ms. Crosby moved to adjourn the meeting at 9:55 a.m. Mr. Rush seconded the motion. All voted in favor and the motion passed.
