# **Message from the TMB President**

As you are undoubtedly aware, the TMB licensee population continues to grow as the state grows. Unfortunately, a growing population also means an inherent increase in complaints against licensees. While the Board has worked with agency staff to implement methods to streamline the complaint resolution

process, we could use some help from our licensees as well.

To my fellow licensees, TMB understands that receiving a letter notifying you that a complaint has been received regarding your practice is stressful and creates a great deal of anxiety. However, did you know that nearly 40% of all complaints are dismissed after receiving an initial response? While most licensees respond quickly to these notices, we have found an increasing number do not respond to a complaint notice within the required timeframe.

This delay not only results in many unnecessary investigations, which can increase licensee stress and anxiety, but also negatively impacts the resources TMB must invest to investigate the many complaints that do warrant further investigation. If you do receive written notice that the Board has received a complaint about you, please make sure to provide a full response by the deadline.

Please note that TMB cannot provide legal advice, so you may consider seeking the advice of an attorney prior to submitting your response. Additionally, please be aware that we cannot give extensions due to statutory deadlines.

On a separate note, about TMB enforcement activities, I have heard from several colleagues that there is confusion within the licensee community about how the TMB handles criminal offense situations. The primary concern seems to be ensuring that these situations are addressed consistently by the Board. When it comes to criminal offenses, it is important to understand that the Board is statutorily required to take a specific action for certain offenses but in other instances, the Board is able to exercise discretion. Although the Board does try to remain consistent in discretionary situations, we also recognize that each situation and the facts surrounding each matter are unique so there is no one-size-fits-all solution. For instance, the Board is required to suspend a physician's license on proof that the physician has been initially convicted of any felony.

However, the Board has discretion for situations where a conviction or deferred adjudication is entered for a misdemeanor. And when exercising its discretion, statute requires the Board to consider certain factors such as whether the offense is directly related to the practice of medicine or involves moral turpitude. In those cases, the Board, after considering the circumstances, may enter a suspension instead of a revocation, and may probate a suspension or a revocation which allows the licensee to continue to practice with certain conditions. Also, in other situations where a conviction has not yet occurred, the Board may still be required by statute to consider a temporary suspension of a license until the criminal charges are resolved.

Please keep in mind that the Board always has a mandate to determine if a licensee poses a continuing threat to patient or public safety. In those situations, the Board

may act to suspend a licensee at any state in the criminal proceedings.

Finally, concerns have been raised about corporate practice of medicine in Texas and specifically what constitutes the corporate practice of medicine.

The corporate practice of medicine is a legal doctrine, which generally prohibits corporations, entities or individuals (i.e. non-physicians) from practicing medicine. Any policies established by a healthcare employer or entity concerning medical-decision making must include physician involvement, input and approval. The physician making medical decisions for an individual patient is responsible for that care including meeting the applicable standard of care.

The purpose of the law is to preserve the vitally important doctor-patient relationship and prevent possible abuses resulting from lay control of corporations employing licensed physicians to practice medicine.

The physician must be free to use their medical judgment without any interference.

TMB cannot provide any legal advice as to a specific situation or organization about whether something is or is not corporate practice. Any time a physician(s) decides to undertake a business venture or agree to an arrangement concerning providing medical services they should strongly consider seeking private legal advice.

Complaints regarding corporate practice of medicine can be filed with TMB just like any other complaint. If TMB receives a complaint regarding the corporate practice of medicine, it will be reviewed and investigated following standard procedure. There are several facts and factors that must be examined when evaluating corporate practice of medicine.

#### **Agency Rule Review**

State agencies are required to periodically conduct a comprehensive review of all of their rules in the Texas Administrative Code. This exercise ensures that agency rules are clear, comprehensive, comport with state statute, and properly serve their intended purpose and constituencies.

Over the past two years Board staff have been engaged in such a review. The result of this review was presented at the most recent Board meeting in August. Some of the most common complaints the agency receives about the current rules are that they are poorly organized, the volume makes it difficult to find specific provisions, and the language is not clear. These criticisms were kept front of mind during the review process and the ultimate result was a reduction in the number of chapters from 40 to 25. This was largely achieved by reorganizing and combining some existing rules, as well as by removing unnecessary, superfluous statutory language from the Texas Administrative Code.

## Physician Fingerprinting Renewal Requirement

As part of recent legislation, physicians are required to submit fingerprints prior to having their license renewed unless they were fingerprinted for licensing after January 15, 2018. Please note that this is a one-time requirement; additional fingerprint results will not be required for subsequent renewals.

Licensees are encouraged to begin the process early. If you wish to submit your fingerprints before your renewal period, please email **Registrations@tmb.state.tx.us** and request instructions for your fingerprint submission, along with the required 6-digit ID number for submitting your fingerprints.

You can complete the fingerprint requirement at any point prior to your license expiration date.

Reminders of the fingerprint requirement will be included in the renewal notice sent out 90 days prior to the licensee's current expiration date. Detailed instructions will be included in the email renewal reminder notices.

# Continuing ED Tracking with CE Broker

As a reminder, the Texas Medical Board has partnered with CE Broker, an online continuing education compliance platform, to provide our licensees with an additional tool to help them more easily find, track, and report continuing education coursework.

Currently all physician, respiratory care practitioner, and acupuncture licensees have the option to establish a free, basic account with CE Broker.

TMB will continue to roll-out access to our remaining licensee population on a quarterly basis by license type

**ADOPTED RULES** Rule Changes Effective July 17, 2024

#### **165. MEDICAL RECORDS**

**New §165.7**, titled Definitions, describes the specific definitions and their sources for certain terms used in the new rules.

**New §165.8**, titled Abortion Ban Exception Performance and Documentation, explains that physicians must comply with all applicable laws, rules, and court opinions related to abortion in Texas. The rule also provides the minimum required information that must be included in the patient's medical record. The rule additionally makes clear that imminence of the threat to life or impairment of a major bodily function is not required to perform an abortion.

**New §165.9**, titled Complaints Regarding Abortions Performed, explains the procedures that the Board will utilize in the event a complaint is received. The rule also explains the limitation of any Board decision and that possible criminal or civil action under the law is separate and independent of any Board decision.

## **Case Review Experts Needed**

- Active practice
- No history of negative peer review action or license restriction
- Acceptable malpractice history
- Initial board certification by an organization that is a member of the American Board of Medical Specialties, the Bureau of Osteopathic Specialists, or the American Board of Oral and Maxillofacial Surgery
