

TEXAS MEDICAL BOARD
LICENSURE COMMITTEE MEETING MINUTES
October 18, 2018

The meeting was called to order 9:44 a.m. by Chair, Timothy Webb. Other Committee members present were Michael Cokinos, George De Loach, D.O., Frank S. Denton, Kandace Farmer, D.O., Jeffrey L. Luna, M.D., Roberto Martinez, M.D., Linda Molina, J.D., Jayaram B. Naidu, M.D. and Karl Swann, M.D.

Mr. Denton moved, and Mr. Cokinos seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Items 2 and 3a. The motion passed. Mr. Webb announced that the meeting would be closed for deliberations at 9:48 a.m. concerning licensee requests and licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

The Executive Session ended at 12:56 p.m. The Licensure Committee conducted hearings to review licensees appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

Agenda Item 2 – Licensee requests.

Licensee #2256 appeared before the Committee in executive session. In open session, **Mr. Denton moved that the committee recommend to the full Board that that the Licensee’s license be returned from retired to active status, contingent upon the following conditions being completed in full:**

- **Within six months from October 18, 2018, passage of the examination for recertification by the American Board of Family Medicine.**
- **Within six months from October 18, 2018, passage of the Texas Medical Jurisprudence Examination.**

- **Within six months from October 18, 2018, completion of a supervised preceptorship in Family Medicine with a minimum of 100 patient encounters. The preceptorship must be completed in a continuous time frame. The preceptorship must be approved by the Executive Director of the Board before the licensee initiates the program.**

This recommendation is based on the applicant's time out of practice. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Agenda Item 3a - Applicants appearing concerning eligibility.

Applicant #2247 appeared before the Committee, with counsel, in executive session. In open session, Mr. Denton moved that the committee recommend to the full Board that the applicant be granted a license under a non-disciplinary Remedial Plan due to unprofessional conduct and action taken by a health care entity.

The Remedial Plan will have the following conditions:

- **Within one year from October 18, 2018, completion of a minimum of 8 hours of continuing medical education, to be completed in the following topics:**
 - **Boundary issues**
- **All continuing medical education hours must meet the requirements of Board Rule 166.2(a)(1)(A).**

Dr. Naidu seconded the motion. After discussion Dr. Luna moved to amend Mr. Denton's motion to recommend to the full Board that the applicant be granted an unrestricted license. Mr. Cokinos seconded the amendment. Ms. Molina, Dr. De Loach, Dr. Naidu, Dr. Martinez, Dr. Swann, Dr. Luna, Dr. Farmer and Mr. Cokinos all voted in favor of the amendment. Mr. Denton voted against the amendment. The motion passed.

The committee then voted on the amended motion to grant the applicant an unrestricted license. Ms. Molina, Dr. De Loach, Dr. Naidu, Dr. Martinez, Dr. Swann, Dr. Luna, Dr. Farmer and Mr. Cokinos all voted in favor. Mr. Denton voted against the motion. The motion passed.

Applicant #2248 appeared before the Committee in executive session. In open session, **Mr. Cokinos** moved that the committee recommend to the full Board that the applicant be granted an unrestricted license. **Dr. Naidu** seconded the motion. The motion passed.

Applicant #2249 appeared before the Committee, with counsel, in executive session. In open session, **Dr. Farmer** moved that the committee recommend to the full Board that the applicant be determined ineligible for a license due to the applicant's failure to practice medicine in an acceptable professional manner consistent with public health and welfare; the applicant being subject to repeated or recurring meritorious health care liability claims that evidence professional incompetence likely to injure the public; and having their license to practice medicine subject to disciplinary action by another state. **Mr. Cokinos** seconded the motion. **Dr. Martinez, Dr. Swann, Dr. Luna, Dr. Farmer** and **Mr. Cokinos** voted in favor. **Ms. Molina, Dr. De Loach, Dr. Naidu** and **Mr. Denton** voted against the motion. The motion passed.

Applicant #1145 appeared before the Committee, with counsel, in executive session. In open session, **Dr. Naidu** moved that the committee recommend to the full Board that the applicant be granted an unrestricted license. **Dr. Farmer** seconded the motion.

Agenda Item 3b – Proposed orders offered by the Executive Director.

Ms. Johnston reported on 2 Remedial Plans offered by the Executive Director and accepted by the applicants. **Mr. Cokinos** moved to recommend to the full Board that the 2 Remedial Plans be approved. **Dr. Farmer** seconded the motion. All voted in favor and the motion passed.

Agenda Item 3c – Physician licensure applicants to be licensed.

Ms. Johnston reported that there were 140 applicants who met all requirements to be considered for permanent licensure by the full Board. **Dr. Farmer** moved to recommend to the full Board that all 140 physician licensure applicants determined to meet eligibility requirements by staff be approved. **Dr. Martinez** seconded the motion. All voted in favor and the motion passed.

Agenda Item 3d – Surgical assistant licensure applicants to be licensed.

Ms. Johnston reported that there were **20** surgical assistant applicants who met all requirements to be considered for licensure by the full Board. **Dr. Farmer moved to recommend to the full Board that all 20 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.**

Agenda Item 3e – Acudetox Specialist applicants to be certified.

Ms. Johnston reported that there was **1** Acudetox specialist applicant who met all requirements to be considered for licensure by the full Board. **Ms. Molina moved to recommend to the full Board that the 1 surgical assistant applicant determined to meet eligibility requirements by staff be approved. Dr. Farmer seconded the motion. All voted in favor and the motion passed.**

Agenda Item 4 – Report on licensure statistics.

Ms. Johnston reported that in Quarter 1 of FY18, 872 new physician licenses were issued in an average processing time of 45 days. In Quarter 1 of FY19, as of 10/10/2018, 611 licenses were issued in an average processing time of 36 days.

Agenda Item 5a – Cancellation of Licenses by request or for incomplete registration – Surgical Assistants. There are none.

Agenda Item 5b – Cancellation of Licenses by request or for incomplete registration – Acudetox. There are none.

Agenda Item 6a -Nonprofit Health Organizations - Applicants for Initial Certification.

Ms. Johnston reported that there were **6** applicants for initial certification as a Nonprofit Health Organization for approval. **Dr. Naidu moved to recommend to the full Board that the 6 requests for initial certification as a Nonprofit Health Organization be approved. Dr. De Loach seconded. All voted in favor and the motion passed.**

Agenda Item 6b - Nonprofit Health Organizations - Requests for Biennial Recertification.

There are none.

Agenda Item 6c - Nonprofit Health Organizations – Cancellation of Certification. Ms. Johnston reported that there were **1** application for cancellation of an organization certified as a Nonprofit Health Organization for approval. **Dr. Swann moved to recommend to the full Board that the 1 request for cancellation of an organization certified as a Nonprofit Health Organization be approved.** Mr. Cokinos seconded. All voted in favor and the motion passed.

Agenda Item 7 –There being no further business, **Dr. Martinez moved to adjourn the meeting.** **Dr. Swann seconded the motion.** All voted in favor and the motion passed. The meeting was adjourned at **1:26 p.m.**
