

**TEXAS MEDICAL BOARD
LICENSURE COMMITTEE MEETING MINUTES
VIDEO CONFERENCE MEETING
MARCH 2, 2023**

The meeting was called to order 9:49 a.m. by Roberto D. Martinez, M.D., Chair. Other Committee members present were George De Loach, D.O., Tomeka M. Herod, Jayaram B. Naidu, M.D. and Sharon Barnes.

Committee members absent were Michael Cokinos, Kandace B. Farmer, D.O., Satish Nayak, M.D. and Ebony Todd, J.D.

Agenda Item 2a. Proposed orders offered by the Executive Director.

Ms. Unterborn reported on **1** Remedial Plan offered by the Executive Director and accepted by the applicant. After discussion **Dr. Naidu moved to recommend to the full Board that the 1 Remedial Plan be approved. Ms. Herod seconded the motion. All voted in favor and the motion passed.**

Agenda Item 2b. Physician licensure applicants to be licensed.

Ms. Unterborn reported that there were **319** applicants who met all requirements to be considered for permanent licensure by the full Board. **Dr. Naidu moved to recommend to the full Board that all 319 physician licensure applicants determined to meet eligibility requirements by staff be approved. Dr. De Loach seconded the motion. All voted in favor and the motion passed.**

Agenda Item 2c. Surgical Assistant licensure applicants to be licensed.

Ms. Unterborn reported that there were **7** surgical assistant applicants who met all requirements to be considered for licensure by the full Board. **Ms. Barnes moved to recommend to the full Board that all 7 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Dr. Naidu seconded the motion. All voted in favor and the motion passed.**

Agenda Item 2d. Acudetox applicants to be certified.

There are none.

Agenda Item 3. Report on Physician licensure statistics.

Non-Compact statistics:

Ms. Unterborn reported that in Quarter 2 of FY 22, 1269 new physician licenses were issued in an average processing time of 29 days. In Quarter 2 of FY 23, 1184 new physician licenses issued in an average processing time of 25 days.

Compact statistics:

Ms. Unterborn reported that in Quarter 2 FY 23, 363 new Compact licenses were issued in an average processing time of 10 days.

Agenda Item 4a. Cancellation of licenses by request or for incomplete registration – Surgical Assistants.

There are none.

Agenda Item 4b. Cancellation of licenses by request or for incomplete registration – Acudetox.

There are none.

Agenda Item 5a. Nonprofit Health Organizations - Applicants for Initial Certification.

Ms. Unterborn reported there were **11** applicants for initial certification as a Nonprofit Health Organization for approval. **Ms. Herod moved to recommend to the full Board that the 11 applicants for initial certification as a Nonprofit Health Organization be approved. Dr. Naidu seconded the motion. All voted in favor and the motion passed.**

Agenda Item 5b. Nonprofit Health Organizations - Requests for Biennial Recertification.

Ms. Unterborn reported there was **109** requests for biennial recertification as a Nonprofit Health Organization for approval. **Dr. Naidu moved to recommend to the full Board that the 109 requests for biennial recertification as a Nonprofit Health Organization be approved. Dr. De Loach seconded the motion. All voted in favor and the motion passed.**

Agenda Item 5c. Nonprofit Health Organizations – Cancellation of organizations certified as Nonprofit Health Organizations.

Ms. Unterborn reported there was **2** organizations for cancellation as a Nonprofit Health Organization for approval. **Ms. Herod moved to recommend to the full Board that the 2 organizations for cancellation as a Nonprofit Health Organization be approved. Dr. Naidu seconded the motion. All voted in favor and the motion passed.**

Agenda Item 6. Report on renewal for Advertising Board Certification.

Ms. Unterborn reported there was **1** renewal of a certifying board that is recognized for the purposes of Advertisement Only.

Agenda Item 7. Discussion, recommendation and possible action regarding proposed amendments to Title 22 of the Texas Administrative Code.

There are none.

Dr. Naidu moved, and Dr. De Loach, seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Items 8 and 9. The motion passed. Dr. Martinez announced that the meeting would be closed for deliberations at 9:57 a.m. concerning licensees and licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

The Executive Session ended at 12:15 p.m. The Licensure Committee conducted hearings to review licensure applicants appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

Agenda Item 8. Licensee requests.

Applicant #2559 appeared before the Committee in executive session. In open session, Dr. De Loach moved that the committee recommend to the full Board that the Licensee's request to return to active status be granted upon completion of the following requirements:

- Completion of 48 formal Category 1 or 1A hours of Continuing Medical Education.**
- At least 2 of the 48 formal hours must involve the study of medical ethics and/or professional responsibility.**
- At least 2 of the 48 formal hours must involve the best practice, alternate treatment options and multi modal approaches to Pain Management and the Prescription of Opioids.**
- At least 1 of the 48 formal hours must be a course in human trafficking prevention as approved by Texas Health and Human Services.**

Dr. Naidu seconded the motion. All voted in favor and the motion passed.

Agenda Item 9. Applicants appearing concerning eligibility.

Applicant #2557 appeared before the committee, with counsel, in executive session. In open session, Dr. Naidu moved that the committee recommend to the full Board that the applicant's appeal be denied and the original determination of ineligibility stand. This recommendation is due to the Applicant's criminal history and time out of active practice. Ms. Herod seconded the motion. All voted in favor and the motion passed.

Applicant #2564 appeared before the committee, with counsel, in executive session. In open session, Ms. Herod moved that the committee recommend to the full Board that the applicant be determined ineligible

for a license due to professionalism issues during residency training. Dr. Naidu seconded the motion. All voted in favor and the motion passed.

10. Adjourn.

There being no further business, Ms. Herod moved to adjourn the meeting. Dr. De Loach seconded the motion. All voted in favor and the motion passed. The meeting was adjourned at 12:21 p.m.
