



TEXAS PHYSICIAN ASSISTANT BOARD

LICENSURE COMMITTEE MEETING MINUTES

July 15, 2016

The meeting was called to order at 9:30 a.m. by the Chair, Teralea Jones, PA-C. Committee members present were Karrie L. Crosby, PA-C, Jennifer L. Clarner, PA-C and Felix C W Koo, M.D.

Agenda Item 2 – Discussion, recommendation, and possible action regarding licensure applicants referred to the Licensure Committee by the Executive Director for determination of eligibility of licensure.

Applicant #637 appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, Ms. Crosby moved to recommend to the full Board that the applicant be granted a Texas physician assistant license under an Agreed Order subject to the following terms and conditions:

- **Restricted to an institutional or group setting that provides continuous full-time, on-site physician supervision.**
- **Applicant shall not** register or otherwise obtain Controlled Substances Registrations until Applicant has received written authorization from the Board. Authority to register for Controlled Substances Registration Certificates may be granted only after Applicant makes written petition and a personal appearance before the Board, a committee of the Board, or authorized Board representatives.
- **Applicant may seek modification after for one year and after that must petition the Board in writing and appear at an ISC.**

Factors contributing to this motion include concerns with the unsupervised practice with a supervised temporary license, prescribing history while under a supervised temporary license and the previous determination of ineligibility for a license by the Licensure Committee on July 12, 2013.

Dr. Koo seconded the motion. All voted in favor and the motion passed.

Applicant #1831 appeared before the Committee on referral by the Executive Director.

The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Dr. Koo moved to recommend to the full Board that the applicant be granted a Texas physician assistant license under a Remedial Plan, subject to the following terms and conditions:**

- **Complete the University of Dallas Remedial Coaching Program and comply with all their recommendations and requirements.**
- **Complete 8 hours of Continuing Medical Education in Professional Communications.**

Factors contributing to this recommendation include the applicant's employment history since 2008 to the present that reflects a pattern of being discharged from employment due to unprofessional conduct or resigning from employment. **Ms. Clarner seconded the motion. All voted in favor. The motion passed.**

Agenda Item 3 - Discussion, recommendation, and possible action regarding review of Physician Assistant applications for permanent licensure. Ms. Johnston reported there were 168 regular applicants and 7 relicensure applicants who met all requirements to be considered for permanent licensure by the full Board. **Ms. Crosby moved to recommend to the full board that all 168 regular applicants and 7 relicensure applicants be approved for permanent licensure. Dr. Koo seconded the motion. All voted in favor and the motion passed.**

Agenda Item 4 – Proposed Orders Offered by the Executive Director – There are none.

Agenda Item 5 - Report on physician assistant licensure process statistics – Ms. Johnston reported that 205 physician assistant licenses were issued in the third quarter of Fiscal Year 2016

in an average of 30 days. In the fourth quarter of Fiscal Year 2016 (as of July 11, 2016) 47 physician assistant licenses were completed in an average of 38 days.

Agenda Item 6 - Discussion, recommendation, and possible action regarding supervised temporary licenses.

Ms. Johnston explained that recent applicants who have been offered a supervised temporary license due to not meeting active practice requirements have proposed working in a setting requiring multiple supervising physicians. Ms. Johnston further explained that Board staff has allowed multiple supervising physicians under a supervised temporary license, but this has historically been no more than three to four physicians and all physicians were registered as a supervising physician. Board staff would like direction from the Committee on what they feel is an appropriate work setting for an applicant working under a supervised temporary license and if it was felt there should be a maximum number of supervising physicians allowed. The Committee indicated they did not want to set an arbitrary number of supervising physicians as the healthcare work environment can vary. It was also felt that multiple physicians should be allowed and directed staff to continue to review these on a case by case basis to ensure the work setting and supervision does not diminish the intention of the supervised temporary license.

Agenda Item 7 - There being no further business, Ms. Crosby moved to adjourn the meeting at 10:35a.m. Dr. Koo seconded the motion. All voted in favor and the motion passed.
