#### TEXAS MEDICAL BOARD

#### LICENSURE COMMITTEE MEETING MINUTES

### October 13, 2016

The meeting was called to order 12:00 p.m. by Chair, Timothy Webb. Committee members present were Michael Arambula, M.D., Pharm.D., Frank S. Denton, Carlos Gallardo, John R. Guerra, D.O., Robert B. Simonson, D.O., and Paulette B. Southard.

Dr. Arambula moved, Mr. Gallardo seconded, that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Items 2a. Discussion, recommendation and possible action regarding applicants for licensure, permits, and certification. The motion passed. Mr. Webb announced that the meeting would be closed for deliberations at 12:01 p.m. concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

The Executive Session ended at 2:11 p.m. The Licensure Committee conducted hearings to review applicants and licensees appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

### Agenda Item 2a - Applicants appearing concerning eligibility.

Applicant #1854 appeared before the Committee, with counsel, in executive session. In open session, Dr. Simonson moved that the committee recommend to the full Board that the applicant granted a physician license. Ms. Southard seconded the motion. All voted in favor. The motion passed.

Applicant #1893 appeared before the Committee, with counsel, in executive session. In open session, Mr. Gallardo moved that the committee recommend to the full Board that the applicant's appeal is denied and the original determination stands. Ms. Southard seconded the motion. All voted in favor. The motion passed.

Applicant #1890 appeared before the Committee, with counsel, in executive session. In open session, Dr. Arambula moved that the committee recommend to the full Board that the applicant's appeal is denied and the original determination stands. During discussion the applicant was encouraged to return to Texas and reapply when he becomes eligible for licensure. Mr. Gallardo seconded the motion. All voted in favor. The motion passed.

Applicant #1882 appeared before the Committee, with counsel, in executive session. In open session, Mr. Denton moved that the committee recommend to the full Board that the applicant granted a physician license. Ms. Southard seconded the motion. All voted in favor. The motion passed.

### Agenda Item 2b - Proposed orders offered by the Executive Director.

Ms. Johnston reported on 9 remedial plans and 2 agreed orders offered by the Executive Director and accepted by applicants. Ms. Southard moved to recommend to the full Board that the remedial plans and orders be approved. Dr. Arambula seconded. All voted in favor. The motion passed.

### Agenda Item 2c – Physician licensure applicants to be licensed.

There were 169 applicants who met all requirements to be considered for permanent licensure by the full Board. Ms. Southard moved to recommend to the full Board that all 169 physician licensure applicants determined to meet eligibility requirements by staff be approved. Mr. Gallardo seconded the motion. All voted in favor. The motion passed.

### Agenda Item 2d – Surgical assistant licensure applicants to be licensed.

There were 6 surgical assistant applicants who met all requirements to be considered for licensure by the full Board. Ms. Southard moved to recommend to the full Board that all 6 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Dr. Arambula seconded the motion. All voted in favor. The motion passed.

### Agenda Item 2e – Acudetox Specialist applicants to be certified.

There was 1 Acudetox Specialist applicant who met all requirements to be considered for certification by the full Board. Ms. Gallardo moved to recommend to the full Board that the 1 Acudetox applicant determined to meet eligibility requirements by staff be approved. Ms. Southard seconded the motion. All voted in favor. The motion passed.

### **Agenda Item 3 – Report on licensure statistics.**

Ms. Johnston reported that in FY15, 4295 new physician licenses were issued in an average processing time of 39 days. Ms. Johnston also reported that in FY16, 4093 new physician licenses were issued in an average of 40 days. Additionally, 2513 new SB 202 licenses were issued between 12/1/15 and 8/31/16.

#### Agenda Item 4a -Nonprofit Health Organizations - Applications for Initial Certification.

There were 2 applications for initial certification as a Nonprofit Health Organization for approval. Ms. Southard moved to recommend to the full Board that the 2 requests for initial certification as a Nonprofit Health Organization be approved. Dr. Arambula seconded. All voted in favor and the motion passed.

Agenda Item 4b - Nonprofit Health Organizations - Applications for Biennial Recertification. There were none.


