Agenda Item #2. Texas Physician Health Program (TXPHP).

A. Discussion, recommendation, and possible action regarding referrals.

Dr. Bhatia moved and Ms. Barnes seconded that TXPHP Case Nos. 21-0719-A MD, 21-0810 MD, and 23-0410 PIT MD be returned to the jurisdiction of the TMB and that TXPHP Case Nos. 14-0141-A MD, 20-1011 DO, 23-0301 MD, and 23-0304 MD remain under the management of TXPHP. Motion carried.
