# Dr. Kirksey Installed as Federation President

# **Governor Reappoints Board Members; Officers Elected**

Governor Rick Perry has reappointed four members of the board, with their terms expiring April 13, 2007: The board also elected officers at its June 5-6 meeting. The reappointments and elected officers are as follows:

**Lee S. Anderson, M.D**., is the President of the Board. Dr. Anderson is an ophthalmologist in Fort Worth and president of Retina Consultants, P.A. He is former president of the Tarrant County Medical Society and is a former trustee of Saint Joseph's Hospital. Dr. Anderson earned his medical degree from the University of Texas Medical Branch at Galveston.

**Thomas D. Kirksey, M.D.**, earned his medical degree from the University of Texas Medical Branch in Galveston and has practiced in Austin as a cardiothoracic and vascular surgeon since 1969. He serves on the board as the chair of the Disciplinary Process Review Committee. He has served as the Medical Director at Brackenridge Hospital in Austin and is a former President of the Travis County Medical Society, the Central Texas Medical Foundation and is on the Board of Directors for the Travis County Heart Association. Dr. Kirksey is also on the President's Council of the University of Texas.

**Eddie J. Miles Jr.** is a public member of the Board. He is the Director of Community Projects for the Bexar County District Attorney's Office, as well as a part-time faculty member of San Antonio College, Palo Alto College and St. Philip's College. He earned a bachelor's degree from North Carolina A&T State University and master's degrees from Troy State University, the University of Oklahoma and Phillip's University. He is a former Mayor Pro Tem of Live Oak, and he serves on the Board of Trustees of the United Way and on the Executive Committee of the San Antonio Branch of the National Association for the Advancement of Colored People. He is president of the Academy Advisory Corporate Council of the Academy of Creative Education, an alternative high school for the North East Independent School District.

**Elvira Pascua-Lim, M.D.,** is a native of the Philippines and a graduate of the University of the Philippines, College of Medicine. She completed her general psychiatry residency training at Texas Tech University Health Sciences Center and her forensic fellowship training at the University of California, Davis. She is the medical director of Lubbock Regional Mental Health Mental Retardation and maintains a private practice in forensic psychiatry.

**Larry Price, D.O.**, is an assistant professor at the Texas A&M University Health Science Center College of Medicine and senior staff cardiologist at Scott and White Clinic in Temple. He is board certified in Internal Medicine, Cardiology, Critical Care Medicine and Cardiac Electrophysiology. He earned his medical degree from the University of North Texas Health Science Center at Fort Worth. At the June 5-6 board meeting, Dr. Price was elected Vice President of the Board.

**Nancy M. Seliger,** a public member of the board, was elected Secretary-Treasurer of the board at the June meeting. Ms. Seliger received a BBA in petroleum land management from the University of Texas at Austin. She works in recruiting and business development for the Underwood law firm in Amarillo. She serves on the M.D. Anderson Board of Visitors and the board of the Amarillo Museum of Art and also volunteers with the Boy Scouts of America, the Texas Lyceum and the Amarillo Symphony Ball.

Dr. Tornelli-Mitchell served as chair of the Credentials Verification Service Committee, on the Licensure Committee, on the Ad Hoc Committee for Integrative and Complementary Medicine, and on the Public Information/Profile Committee.

**Mr. Ed Hicks Sr.,** a public member from Corpus Christi, served from 1997-2003. He was Secretary-Treasurer of the board from 2000-2003, chair of the Finance Committee and was on the Legislative and Disciplinary Process Review Committees.

**Peter Chang, M.D**., of Houston, served on the board from 1997-2003. He was chair of the Standing Orders Committee and served on the Licensure and Public Information/Profile Committees.

# **Governor Names Three to Acupuncture Board**

Governor Rick Perry has named three people to the Texas State Board of Acupuncture Examiners. They are **Sheng Ting (Sam) Chen**, of Austin; **Hoang Xiong Ho, L.Ac.**, of San Antonio; and **Terry G. Rascoe, M.D.**, of Temple.

**Mr. Chen**, an Austin businessman, received a B.S. in Business Administration from Fu Jun University, Taipei, Taiwan. He has visited China with U.S. and local officials to promote commerce, and is currently president of the Austin-Xishuangbanna Sister Cities Committee. He owns Sam Chen Inc., a property management company, and is involved with motel and hotel design, construction and management.

**Mr. Ho** completed his undergraduate education at Meng Seng College in Phnom Penh, Cambodia, in 1969, as well as a three-year apprenticeship in acupuncture, also in Cambodia. He has completed additional training in Traditional Chinese Medicine at Shanghai College in Shanghai, China. He has been nationally certified in acupuncture with NCCAOM since 1989. He has had an established practice in San Antonio since 1984 and in Kerrville since 1993.

**Dr. Rascoe** obtained his undergraduate degree from Baylor University in 1981 and his medical degree from Texas A & M in 1985. He is a diplomate of the American Board of Family Practice and the American Board of Holistic Medicine. Dr. Rascoe serves as the Medical Director of the Scott & White Northside Clinic in Temple. He received his acupuncture training from UCLA in 1999 and uses this therapy primarily to treat chronic pain symptoms.

<u>Chapter 173</u>, Physician Profiles. Amendments to §173.1 regarding board actions contained in the profile.

<u>Chapter 174</u>, Telemedicine. Amendments to §§174.1-.6, .10, and .12-.14 to clarify definitions and informed consent and for general cleanup of the chapter; and new §174.17 regarding the use of the Internet in medical practice.

<u>Chapter 175</u>, Fees, Penalties, and Applications. Amendment to §§175.1 and 175.4 relating to fees and applications required for reissuance of a physician assistant license.

<u>Chapter 177</u>, Certification of Non-Profit Health Organizations. Amendment to §177.16 regarding the complaint procedure notification.

<u>Chapter 179</u>, Investigation Files. Rule review and amendments to §§179.1-.4 repeal of §179.5-.6 and new §179.5 for general cleanup of the chapter and to update statutory cites.

<u>Chapter 183</u>, Acupuncture. Amendments to §§183.1-183.4 and 183.6-183.18 for general cleanup of the chapter and the complaint procedure notification. Amendment to §183.3 regarding the number of board meetings to be held during a year and amendment to §183.20 regarding continuing acupuncture education requirements.

<u>Chapter 184</u>, Surgical Assistants. Amendments to §§184.4, 184.6, and 184.8 regarding licensure documentation, license renewal, and examinations; and amendments to §§184.19, 184.21, and 184.25 regarding the complaint procedure notification, correction of the name of a surgical assistant association, and continuing education for surgical assistants. Amendment to §184.6 regarding licensure documentation for examinations.

<u>Chapter 185</u>, Physician Assistants. Amendment to §185.3 regarding the number of board meetings to be held during a year and proposed amendment to §185.16 concerning the supervision of physician assistants by hospital emergency room directors.

<u>Chapter 187</u>, Procedural Rules. Amendments to §§187.10, .12, and .13 which will formalize the procedure whereby the Executive Director has the authority to offer restricted licenses and permits; and amendments to §§187.16, 187.18, 187.27, 187.28, and 187.39 regarding informal board proceedings, State Office of Administrative Hearings proceedings, default judgments,

discovery, and costs of administrative hearings. Amendments to §§187.18 and 187.58 regarding the role of the board's legal counsel during a hearing.

<u>Chapter 188</u>, Complaint Procedure Notification. Rule review and amendment to §188.1 regarding the forms for complaint procedure notification.

<u>Chapter 190</u>, Disciplinary Guidelines. Rule review with no recommended changes.

<u>Chapter 191</u>, District Review Committees. Rule review and proposed amendments to §§191.1 and 191.3-191.5 for general cleanup of the chapter.

<u>Chapter 193</u>, Standing Delegation Orders. Amendments to §193.6 regarding supervision waiver requests.

<u>Chapter 196</u>, Voluntary Surrender of a Medical License. Rule review and amendments to §§196.1-.5 for general cleanup of the chapter.

<u>Chapter 197</u>, Emergency Medical Services. Rule review and amendments to §§197.2 and 197.3 regarding definitions and responsibilities of the off-line medical director.

<u>Chapter 198</u>, Unlicensed Practice. Rule review with no changes.

<u>Chapter 199</u>, Public Information. Amendment to §199.2 regarding clarification of the deadline for members of the public to submit requests to speak to the Public Information Committee.

<u>Chapter 200</u>, Standards for Physicians Practicing Complementary and Alternative Medicine (Note: new title). Rule review and amendments to §§200.1-.2 for general cleanup of the chapter. # **Disciplinary Actions**

# Aboloye, Pius A., M.D., Flower Mound, TX, Lic. #BP-10002194

A Board Order was entered on 12-13-02 suspending the physician's Texas Postgraduate Resident Permit. Action due to his incarceration in a state penitentiary. Dr. Aboloye may file a Motion for Rehearing within 20 days of the Order. If a Motion for Rehearing is filed and the Board denies the motion, the Order is final. If a Motion for Rehearing is filed and the Board grants the motion, the Order is not final and a hearing will be scheduled. Dr. Aboloye did not file a motion for rehearing; therefore the order was effective 1-09-03.

#### Adelman, Harold F., M.D., Desoto, TX, Lic. #H3965

An Agreed Order was entered on 6-6-03 suspending the physician's license

for six months; after this period of suspension, the suspension is stayed and the physician is placed on probation for 10 years under certain terms and conditions. Action due to failure to practice medicine in an acceptable professional manner consistent with public health and welfare.

# Ahmed, Faiz, M.D., Houston, TX, Lic. #J4683

An Agreed Order was entered on 2-7-03 restricting the physician's license for 10 years under certain terms and conditions, including that he not provide care to any female patients. Action due to unprofessional or dishonorable conduct that is likely to deceive, defraud, or injure the public; and disciplinary action by peers.

# Aitken, Phil A., M.D., South Burlington, VT, Lic. #D4008

An Agreed Order was entered on 2-7-03 indefinitely suspending the physician's medical license. Action due to disciplinary action by another state and unprofessional or dishonorable conduct.

# Alsop, Ernest C., M.D., Rockport, TX, Lic. #J6300

An Agreed Order was entered on 2-7-03 indefinitely suspending the physician's license. Action due to intemperate use of alcohol or drugs; inability to practice medicine with reasonable skill and safety because of illness or substance abuse; unprofessional or dishonorable conduct that is likely to deceive, defraud, or injure the public; and failure to practice medicine consistent with public health and welfare.

# Arango, Luis F., M.D., Mission, TX, Lic. #G2632

An Agreed Order was entered on 3-28-03 restricting the physician's license for five years under certain terms and conditions. Action due to disciplinary action by a state professional medical association or society that was based on unprofessional conduct or professional incompetence that was likely to harm the public and that was appropriate and reasonably supported by evidence submitted to the Board.

# Arauzo, Arturo C., M.D., Plano, TX, Lic. #G2896

An Agreed Order was entered on 12-13-02 assessing an administrative penalty in the amount of \$1,000. Action due to violation of Board rules.

# Autrey, Ezell S., M.D., Dallas, TX, Lic. #G1320

An Agreed Order was entered on 6-6-03 assessing an administrative penalty in the amount of \$1,000. Action due to violation of Board rules.

# Avila, Fernando, M.D., San Antonio, TX, Lic. #G2899

An Agreed Order was entered on 3-28-03 assessing an administrative penalty in the amount of \$1,000. Action due to violation of Board rules relating to release of medical records.

# Aziz, Youssef, M.D., The Woodlands, TX, Lic. #F5144

An Agreed Order was entered on 12-13-02 restricting the physician's license. Action due to failure to practice medicine in an acceptable professional manner consistent with public health and welfare.

# Bailly, George A., D.O., Houston, TX, Lic. #L0009

An Agreed Order was entered on 3

# Baker, David R., M.D., Sulphur, OK, Lic. #D3142

An Agreed Order was entered on 2-7-03 suspending the physician's medical license; however, the suspension was stayed and the physician was placed on probation for seven years under certain terms and conditions, including restriction of prescriptive authority and 24 hours CME each year in addiction medicine and medical record-keeping. Action due to violation of Board rules relating to medical records and pain treatment; and unprofessional or dishonorable conduct that is likely to deceive, defraud, or injure the public.

# Baker, Merrimon W., M.D., Cleveland, TX, Lic. #G4807

An Agreed Order was entered on 6-6-03 publicly reprimanding the physician and assessing an administrative penalty in the amount of \$10,000. Action due to failure to provide medical records when requested by the Board within two weeks of the request.

# Baribeau, Alan D., M.D., San Antonio, TX, Lic. #D9352

An Agreed Order was entered on 12-13-02 assessing an administrative penalty in the amount of \$5,000. Action due to violation of Board rules.

# Barnes, Stephen A., M.D., Houston, TX, Lic. #K5800

An Order was entered on 5-27-03 suspending the physician's medical license. Action due to unprofessional or dishonorable conduct that is likely to deceive or defraud the public or injure the public, and using alcohol or drugs in an intemperate manner that in the Board's opinion could endanger a patient's life.

# Barnett, Stephen E., M.D., Austin, TX, Lic. #D3147

An Agreed Order was entered on 12-13-02 assessing an administrative penalty in the amount of \$5,000. Action due to violation of Board rules.

# Barr, John C., M.D., Heath, TX, Lic. #J4704

On 6-6-03, the Board voted to order the revocation of the physician's Texas medical license. Action based on unprofessional or dishonorable conduct that is likely to deceive or defraud the public or injure the public. The physician may file a Motion for Rehearing within 20 days of the Order. If a Motion for Rehearing is filed and the Board denies the motion, the Order is final. If a Motion for Rehearing is filed and the Board grants the motion, the Order is not final and a hearing will be scheduled.

# Barzune, Lawrence, M.D., Dallas, TX, Lic. #D5911

An Agreed Order was entered on 3-28-03 assessing an administrative penalty in the amount of \$1,000. Action due to violation of Board rules relating to release of medical records.

# Beggs, Tiffany L., D.O., Vidor, TX, Lic. #K8875

An Agreed Order was entered on 5-6-03 suspending the physician's license, staying the suspension, and placing the physician on probation for five years under certain terms and conditions. Action due to inability to practice medicine with reasonable skill and safety to patients because of illness,

drunkenness, or excessive use of drugs, narcotics, chemicals, or another substance, or because of a mental or physical condition.

# Beyer, David M., D.O., Fort Worth, TX, Lic. #D5350

An Agreed Order was entered on 12-13-02 placing the physician under certain terms and conditions for one year. Action due to violation of Board rules.

# Biddix, Jerry W., M.D., Winters, TX, Lic. #E3855

An Agreed Order was entered on 6-6-03 placing the physician under certain terms and conditions for two years. Action due to failure to practice medicine consistent with public health and welfare.

# Blanchard, David E., D.O., Corpus Christi, TX, Lic. #J3743

An Agreed Order was entered on 10-4-02 publicly reprimanding the physician. Action due to disciplinary action by another state.

# Bohan, Timothy P., M.D., Houston, TX, Lic. #H3784

An Agreed Order was entered on 3-28-03 assessing an administrative penalty in the amount of \$1,000. Action due to violation of Board Rules relating to failure to deliver the medical records subpoenaed within the required time period.

# Bowman, Albert, M.D., Houston, TX, Lic. #D3161

An Agreed Order was entered on 2-7-03 publicly reprimanding the physician and assessing an administrative penalty in the amount of \$2,500 and requiring 20 hours CME in record-keeping and risk management and monitoring of prescriptions. Action due to failure to maintain adequate medical records.

# Brackett, Fred B., M.D., Corpus Christi, TX, Lic. #E7836

An Agreed Order was entered on 6-6-03 assessing an administrative penalty in the amount of \$5,000. Action due to disciplinary action by peers.

# Bransford, Paris, M.D., Pasadena, TX, Lic. #D7920

An Agreed Order was entered on 3-28-03 in which the physician voluntarily and permanently surrendered his Texas medical license. Action due to physician's inability to practice medicine with reasonable skill and safety due to illness.

# Brown, John D., M.D., Houston, TX, Institutional Permit #40159

An Order was entered on 6-4-03 suspending the physician's institutional permit. Action due to unprofessional or dishonorable conduct that is likely to deceive or defraud the public or injure the public, and intemperate use of alcohol or drugs that in the Board's opinion could endanger a patient's life.

# Brown, Michael G., M.D., Houston, TX, Lic. #G3190

A Temporary Suspension Order was entered on 11-6-02 temporarily suspending the physician's license due to evidence and information that the physician's continuation in the practice of medicine would constitute a continuing threat to public welfare. An agreed order was entered on 12-18-02 revoking the physician's license; however, the revocation was stayed and the physician was placed on probation for 10 years under certain terms and conditions. In addition, an administrative penalty in the amount of \$25,000 was assessed. Action due to unprofessional or dishonorable conduct that is likely to deceive or defraud the public or injure the public; and violation of a previous order of the board.

# Caballero, Yuri J., M.D., El Paso, TX, Lic. #J8938

An Agreed Order was entered on 1-15-03 assessing an administrative penalty in the amount of \$1,000. Action due to false and misleading statement, document, or certificate in an application for a license.

# Cammack, James T., M.D., Kerrville, TX, Lic. #H5696

A Temporary Suspension Order was entered on 6-4-03 temporarily suspending the physician's license due to evidence and information that the physician's continuation in the practice of medicine would constitute a continuing threat to public welfare. The allegations related to the application for temporary suspension are to be the subject of a disciplinary hearing as soon as can be accomplished under the Administrative Procedure Act and Medical Practice Act. It is further ordered that the Temporary Suspension Order shall remain in effect until such time as it is superseded by a subsequent order of the Board.

# Capitaine, Raul, M.D., Corpus Christi, TX, Lic. #H4885

An Agreed Order was entered on 3-28-03 publicly reprimanding the physician, assessing an administrative penalty in the amount of \$5,000, and restricting his license under certain terms and conditions. Action due to unprofessional or dishonorable conduct that is likely to deceive or defraud the public; and failure to supervise adequately the activities of those acting under physician's supervision.

# Chambless, Nelson, M.D., Miami, FL, Lic. #H1050

An Agreed Order was entered on 6-6-03 restricting the physician's license under certain terms and conditions. Action due to intemperate use of alcohol or drugs that in the Board's opinion could endanger a patient's life.

# Chandler, Eddie Ray, M.D., Bowie, TX, Lic. #D4066

An Agreed Order was entered on 4-8-03 restricting the physician's license for three years under certain terms and conditions. Action due to failure to practice medicine in an acceptable professional manner consistent with public health and welfare, unprofessional or dishonorable conduct that is likely to deceive or defraud the public or injure the public, prescribing or dispensing to habitual user, nontherapeutic prescribing or treatment, and administering dangerous or controlled drugs in an improper manner.

# Chaturvedi, Ram P., M.D., Dallas, TX, Lic. #J0928

An Agreed Order was entered on 6-6-03 publicly reprimanding the physician, assessing an administrative penalty in the amount of \$10,000, and placing the physician's license under certain terms and conditions. Action due to failure to practice medicine in an acceptable professional manner consistent with public health and welfare.

#### Chepko, James D., M.D., Houston, TX, Lic. #F0931

An Agreed Order was entered on 6-6-03 restricting the physician's license for five years under certain terms and conditions. Action due to prescribing or administering a drug or treatment that is nontherapeutic in nature or nontherapeutic in the manner the drug or treatment is administered or prescribed, and failure to maintain adequate medical records for each patient and failure to follow Board guidelines for the treatment of pain.

#### Clark, Beverly A., M.D., Amarillo, TX, Lic. #G0588

An Agreed Order was entered on 6-6-03 in which the physician voluntarily and permanently surrendered her Texas medical license. Action due to unprofessional conduct.

#### Clark, Cordell, M.D., Dallas, TX, Lic. #F8827

On 12-13-02 the Board voted to revoke the physician's license. Action due to unprofessional or dishonorable conduct likely to deceive or defraud the public due to the physician's practicing medicine while his license was suspended. This order was final and effective 12-13-02.

# Corley, Ronald G., M.D., Lufkin, TX, Lic. #D8519

An Agreed Order was entered on 12-13-02 restricting the physician's license for three years under certain terms and conditions. Action due to prescribing or administering a drug or treatment that is nontherapeutic in nature or nontherapeutic in the manner the drug or treatment is administered or prescribed.

# Debenedetto, Richard B., M.D., Amarillo, TX, Lic. #J9579

An Agreed Order was entered on 2-7-03 publicly reprimanding the physician; requiring 10 hours of CME in ethics; and passage of the Texas Medical Jurisprudence Exam. Action due to unprofessional or dishonorable conduct that is likely to deceive, defraud, or injure the public; and administering dangerous or controlled drugs in an improper manner.

# De Carvalho, Guaracy F., M.D., George West, TX, Lic. #E3677

An Agreed Order was entered on 6-6-03 restricting the physician's license for three years under certain terms and conditions. Action due to nontherapeutic prescribing or treatment, and administering dangerous or controlled drugs in an improper manner.

#### Dinh, Quan A., M.D., Salinas, CA, Lic. #J8516

An Agreed Order was entered on 6-6-03 revoking the physician's license. Action due to disciplinary action taken by another state.

# Ellis, Neely J., M.D., Houston, TX, Lic. #C3647

On 3-28-03, the Board voted to order the revocation of the physician's Texas medical license and assess an administrative penalty in the amount of \$10,000. Action based on unprofessional conduct and nontherapeutic prescribing or treatment. On 6-6-03, a request for an extension to file a motion for rehearing filed by Dr. Ellis was not approved by the Board. Therefore, the order dated 4-21-03 was final 6-6-03.

# Gailiunas, Peter, Jr., M.D., Dallas, TX, Lic. #F2253

An Agreed Order was entered on 2-7-03 requiring five hours of CME in ethics and assessing an administrative penalty in the amount of \$5,000. Action due to violation of Board rules relating to improper billing; and unprofessional conduct.

#### Garcia, Francisco J., M.D., San Antonio, TX, Lic. #G8846

An Agreed Order was entered on 3-28-03 assessing an administrative penalty in the amount of \$500. Action due to failure to release medical records in a timely manner.

# Garza, Gumaro, M.D., Edinburg, TX, Lic. #E7943

An Agreed Order was entered on 2-7-03 assessing an administrative penalty in the amount of \$6,000. Action due to violation of Board rules regarding maintenance of adequate medical records.

# Update on 78th Legislative Session's Impact on TMB

Senate Bill 104, passed unanimously by both the Texas House of Representative and the Senate, will strengthen regulation of the practice of medicine in Texas. The bill, effective September 1, was introduced by Sen. Jane Nelson (R-Flower Mound) and sponsored in the House by Rep. Ray Allen (R-Grand Prairie).

The legislation encompasses both licensure and enforcement and adds new reporting requirements. Provisions include the following:

- **Licensure:** Major issues are the biennial registration process, a new \$80 license surcharge and many minor changes involving rules and processes.
- **Physician Profile:** The physician profile is expanded to include a description of settled/paid malpractice claims and removes all 10-year limits on reporting criminal and disciplinary history. The profile format must make information easily available to the public.
- **Enforcement:** Major issues are implementation of the expert panel for standard of care cases, adoption of a schedule of disciplinary sanctions, new temporary restriction/suspension provisions, a 180-day deadline to schedule informal settlement conferences, and changes to reporting and investigations regarding medical malpractice claims. There are numerous changes to rules and processes regarding investigations and complaints.
- **Reporting requirements:** The statute adds a new report of investigations pending over one year old and a statistical report of all complaints by category and dispositions. TMB will no longer be required to report all open complaints to health care entities and will now report only those pending complaints assigned for legal action. The Texas Workers Compensation Commission is required to report physician offenses to TMB.
- **Malpractice reporting:** The current requirement for an insurer to provide TMB all "notice of claim letters" is revised to require only reports of settlements and expert witness reports filed. TMB will be required to investigate the medical competency of physicians against whom three or more expert reports have been filed in three separate lawsuits within five years.

With passage of SB 104, TMB was also appropriated \$6,522,730 for enforcement for the biennium and an additional 20 staff positions. Anderson, M.D., said, "We are now ready to move forward with new language, new funding and new resolve."
