

**TEXAS MEDICAL BOARD**  
**LICENSURE COMMITTEE MEETING MINUTES**  
**February 28, 2019**

**The meeting was called to order 10:15 a.m.** by Chair, Timothy Webb, J.D. Other Committee members present were Michael Cokinos, George De Loach, D.O., Frank S. Denton, Kandace Farmer, D.O., Jeffrey L. Luna, M.D., Roberto Martinez, M.D., Linda Molina, J.D. and Karl Swann, M.D. Committee member absent was Jayaram B. Naidu, M.D.

**Agenda Item 2 – Licensee requests.** There are none

**Mr. Cokinos moved, and Dr. Farmer seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Item 3a. The motion passed.** Mr. Webb announced that the meeting would be closed for deliberations at 10:18 a.m. concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

**The Executive Session ended at 2:57 p.m.** The Licensure Committee conducted hearings to review licensees appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

**Agenda Item 3a - Applicants appearing concerning eligibility.**

**Applicant #2280** appeared before the Committee, with counsel, in executive session. In open session, **Dr. Swann moved that the applicant’s license be reinstated subject to Agreed Order with the following stipulations:**

- **The applicant shall not apply for a federal Controlled Substance Number. This term may not be modified for the life of the license.**

- **Within ninety days from February 28, 2019, the applicant must contact and register for competency evaluation by KSTAR.**
- **Within one year from February 28, 2019, submit to an evaluation by KSTAR and comply with all recommendations.**

**This recommendation is due to the applicant's disciplinary history with the TMB, revocation of their Texas medical license, and time out of the active practice of medicine. Dr. Martinez seconded the motion.**

**Dr. Luna then proposed an amendment to the motion:**

- **After five years from entry date of the order, the applicant can request modification to order to request they be allowed to apply for a federal Controlled Substance Number.**

**Dr. Farmer seconded the motion. All voted in favor of the amendment and the amendment passed.**

**Dr. Luna then moved that the amended motion be accepted. Dr. Farmer seconded the motion. All voted in favor of the amended motion and the motion passed.**

**Applicant #2281 appeared before the Committee, with counsel, in executive session. In open session, Mr. Cokinos moved that the committee recommend to the full Board that the Applicant's request for reinstatement of their license be deferred pending completion of the following:**

- **Within one year from February 28, 2019, submit to an in-depth psychiatric examination evaluation by a board certified forensic psychiatrist approved by the Executive Director in order to determine their fitness to practice.**
- **Upon receipt of the in-depth evaluation, the applicant be required to reappear before the Committee for further consideration.**

**This recommendation is due to the applicant's disciplinary history, revocation of their Texas medical license, and time out of the active practice of medicine. Dr. Farmer seconded the motion. All voted in favor and the motion passed.**

**Applicant #2282** appeared before the Committee, with counsel, in executive session. In open session, **Mr. Denton** moved that the committee recommend to the full Board that a determination be deferred pending completion of the following:

- **Within one year from February 28, 2019, submit to an evaluation by KSTAR and comply with all recommendations.**
- **The applicant will receive a private referral to the Texas Physician's Health Program (TXPHP) and comply with all recommendations.**
- **Upon satisfactory completion of KSTAR and all recommendations and resolution with the TXPHP, the application be referred to the Executive Director for unrestricted licensure.**

**This recommendation is due to the applicant's disciplinary history, impairment history and time out of the active practice of medicine. Dr. Farmer seconded the motion. All voted in favor and the motion passed.**

**Applicant #2286** appeared before the Committee in executive session. In open session, **Dr. DeLoach** moved that the committee recommend to the full Board that the applicant be granted an unrestricted license. **Mr. Cokinos** seconded the motion. All voted in favor and the motion passed.

**Applicant #2287** appeared before the Committee, with counsel, in executive session. In open session, **Dr. Farmer** moved that the committee recommend to the full Board that the applicant be determined ineligible for a license due to the applicant's impairment history, disciplinary history and time out of the active practice of medicine. **Mr. Cokinos** seconded the motion. All voted in favor and the motion passed.

**Agenda Item 3b – Proposed orders offered by the Executive Director.**

Ms. Johnston reported on **2 Remedial Plans** offered by the Executive Director and accepted by the applicants. **Ms. Molina** moved to recommend to the full Board that the **2 Remedial Plans** be approved. **Dr. Farmer** seconded the motion. All voted in favor and the motion passed.

**Agenda Item 3c – Physician licensure applicants to be licensed.**

Ms. Johnston reported that there were **236** applicants who met all requirements to be considered for permanent licensure by the full Board. **Dr. Farmer moved to recommend to the full Board that all 236 physician licensure applicants determined to meet eligibility requirements by staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 3d – Surgical assistant licensure applicants to be licensed.**

Ms. Johnston reported that were **14** surgical assistant applicants who met all requirements to be considered for licensure by the full Board. **Dr. Farmer moved to recommend to the full Board that all 14 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Ms. Molina seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 3e – Acudetox Specialist applicants to be certified.**

Ms. Johnston reported that was **6** Acudetox specialist applicant who met all requirements to be considered for licensure by the full Board. **Ms. Molina moved to recommend to the full Board that the 6 Acudetox specialist applicant determined to meet eligibility requirements by staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 4 – Report on licensure statistics.**

Ms. Johnston reported that in Quarter 2 of FY18, 831 new physician licenses were issued in an average processing time of 34 days. In Quarter 2 of FY19 (as of 2/21/19), 1068 licenses were issued in an average processing time of 36 days. In Quarter 1 and Quarter 2 of FY19 (as of 2/21/19), 1975 licenses were issued in an average processing time of 37 days.

**Agenda Item 5a – Cancellation of Licenses by request or for incomplete registration – Surgical Assistants.** There are none.

**Agenda Item 5b – Cancellation of Licenses by request or for incomplete registration – Acudetox.** There are none.

**Agenda Item 6a -Nonprofit Health Organizations - Applicants for Initial Certification.**

Ms. Johnston reported that were **13** applicants for initial certification as a Nonprofit Health Organization for approval. **Dr. Farmer moved to recommend to the full Board that the 13 requests for initial certification as a Nonprofit Health Organization be approved.** Ms. Molina seconded the motion. All voted in favor and the motion passed.

**Agenda Item 6b - Nonprofit Health Organizations - Requests for Biennial Recertification.**

Ms. Johnston reported that were **50** requests for biennial certification as a Nonprofit Health Organization for approval. **Ms. Molina moved to recommend to the full Board that the 50 requests for biennial certification as a Nonprofit Health Organization be approved.** Dr. Farmer seconded. All voted in favor and the motion passed.

**Agenda Item 6c - Nonprofit Health Organizations – Cancellation of Certification.**

There are none.

**Agenda Item 7 – Proposed amendments to Title 22 of the Texas Administrative Code.**

There are none.

**Agenda Item 8 – Adjourn.**
