

**TEXAS PHYSICIANS ASSISTANT BOARD**

**Agenda Item #2.** Discussion, recommendation, and possible action regarding referrals and reports from the Texas Physician Health Program.

The Executive Director, Dr. Brad Fitzwater, presented the status of certain cases in PHP's current caseload to the Discipline & Ethics Committee for possible referral back to the Board and requested additional guidance.

**Dr. Koo moved, and Mr. Bulls seconded that PHP Case # 1 be returned back to the jurisdiction of the Physician Assistant Board. Motion carried.**
