TMB disciplines 33 physicians at March meeting

At its March 21, 2025, meeting, the Texas Medical Board disciplined 33 licensed physicians.

The disciplinary actions included: two orders related to violation of Board rules, one related to impairment, one order related to nontherapeutic prescribing, 12 orders related to peer review or other states' actions, eight orders related to standard of care, one order related to unprofessional conduct, one Consent Order, six Mediated Settlement Agreed Orders, and one Final Order. The Board also ratified four cease-and-desist orders.
