

TEXAS STATE BOARD OF ACUPUNCTURE EXAMINERS

LICENSURE COMMITTEE MEETING MINUTES

October 9, 2015

The meeting was called to order at 9:04 a.m. by the Chair, Allen Cline, L.Ac. Committee members present were Rachelle Webb, L.Ac. and Rey Ximenes, M.D.

Agenda Item 2 – Discussion, recommendation, and possible action regarding applicants appearing concerning eligibility

Applicant #1740 appeared before the Committee to appeal the determination of ineligibility by the Executive Director due to their inability to provide proof they meet all statutory requirements for licensure. **Dr. Ximenes moved that the committee recommend to the full Board that the applicant's appeal is denied and the original determination of ineligibility stands.** This recommendation is based on the applicant's inability to provide proof of his compliance with all the requirements for acupuncture licensure in Texas. Factors influencing this recommendation include the Board being bound by the statutory requirements for acupuncture licensure. **The committee also directed staff to review this applicant's case to determine if there can be a statutory remedy to any of the requirements the applicant did not meet, provide the applicant with information on the Distinguished Professor Temporary License, advise him to as to his licensure deficiencies, and research the possibility of creating a conceded eminence license.**

Applicant #1741 appeared before the Committee with legal counsel on referral by the Executive Director due to his criminal history. **Ms. Webb moved to recommend to the full Board that the applicant be granted a license under an Agreed Order with the following terms and conditions:**

• The length of this order shall be for a period of 12 (twelve) months.

- The applicant work in a group or institutional setting that provides continuous fulltime, on-site supervision by a licensed acupuncturist.
- The supervising acupuncturist must submit quarterly reports to the Board.

Factors contributing to this recommendation include the applicant has no evidence of criminal charges since 2009 and was successfully discharged from 2 (two) year of community supervision in 2012. **Dr. Ximenes seconded. All voted in favor. The motion passed.**

Agenda Item 3 - Discussion, recommendation, and possible action regarding applicants for a Texas Acupuncture License: There were **43** licensure applicants who met all requirements to be considered for acupuncture licensure by the Texas State Board of Acupuncture Examiners (TSBAE). **Dr. Ximenes moved, Ms. Webb seconded and the motion passed to recommend to the full board that the 43 licensure applicants be approved for licenses and that their names be listed as part of the minutes of this Committee.**

Agenda Item 4 – Discussion, recommendation, and possible action regarding proposed orders offered by the Executive Director. There were none

Agenda Item 5 - Discussion, recommendation, and possible action regarding fingerprinting acupuncturists. Ms. Johnston explained that fingerprinting is not a standard requirement for acupuncture applicants, as it is for physician licensure and physician assistant applicants. Ms. Johnston also discussed how fingerprinting will be required for all four of the new license types transferred from the Department of State Health Services (DSHS). The committee directed staff to start requiring fingerprints for physician assistant licensure applicants.

There being no further business, the meeting was adjourned at 9:47 a.m.
