TEXAS MEDICAL BOARD LICENSURE COMMITTEE MEETING MINUTES June 11, 2015

The meeting was called to order 9:25 a.m. on June 11, 2015 by Chair, Michael Arambula, M.D. Committee members present were Frank S. Denton; Carlos Gallardo, Robert B. Simonson, D.O.; Wynne M. Snoots, M.D., Paulette B. Southard and Timothy Webb.

Agenda Item 2 - Discussion, recommendation, and possible action regarding Board Approved Fellowships. Dr. Bredt provided the committee with examples of two fellowship applications, one which required the completion of a residency training program and another which only required completion of two years of residency training, but then progressed into a sub-speciality area. Following discussion, the Committee directed Dr. Bredt to consider fellowships that are actually specialized residency training for Texas Board approved fellowships, provided that the training indicates a specialized progression, and that General Counsel has the opportunity to do a legal analysis on the existing Board Rule.

Mr. Gallardo moved, Ms. Southard seconded, that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda items 3 and 4a. The motion passed. Dr. Arambula announced that the meeting would be closed for deliberations at 9:43 a.m. concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

The Executive Session ended at 12:40 p.m.

The Licensure Committee conducted hearings to review applicants and licensees appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

Agenda Item 3 - Discussion, recommendation, and possible action regarding Licensee Requests

Licensee #1682 appeared before the Committee, with counsel, in executive session, upon referral from the Executive Director due to the licensee's request to return to active status from Voluntary Charity Care

status. Following discussion, **Mr. Denton moved to recommend to the full Board that the request to** reactivate the retired license be approved. Mr. Gallardo seconded the motion. All voted in favor. The motion passed.

Agenda Item 4a - Applicants appearing concerning eligibility

Applicant #1672 appeared before the Committee, with counsel, in executive session. In open session, **Mr. Gallardo moved that the committee recommend to the full Board that the applicant be granted** a physician in training permit. Mr. Denton seconded the motion. All voted in favor. The motion passed.

Applicant #1673 appeared before the Committee in executive session. In open session, **Mr. Gallardo moved that the committee recommend to the full Board that the applicant's license be reinstated subject to an Agreed Order with the following conditions:**

- Administrative Penalty in the amount of \$5000;
- 8 hours of continuing medical education in Medical Record Keeping;
- 8 hours of continuing medical education in Risk Management; and
- 8 hours of continuing medical education in Ethics

This recommendation is based on unprofessional conduct. Ms. Southard seconded. All voted in favor. The motion passed.

Applicant #1679 appeared before the Committee, with counsel, in executive session. In open session, Mr. Webb moved that the committee recommend to the full Board that the applicant be granted a license subject to an Agreed Order under following conditions:

• Practice restricted to a group or institutional setting

This recommendation is based on unprofessional conduct and disciplinary action taken by a health care entity. Alternatively, if applicant does not elect to sign the proposed order, applicant may withdraw the application for full license and upon receipt within one calendar year of a request for a physician in training permit of no less than one year, a physician in training permit may be granted by the Executive Director. Mr. Gallardo seconded the motion. All voted in favor. The motion passed. **Applicant #1688** appeared before the Committee in executive session. In open session, **Mr. Webb** moved that the committee recommend to the full Board that the Applicant be granted a physician in training permit subject to an Agreed Order with the following conditions:

- Submit to a forensic psychiatric evaluation and comply with all recommendations of that evaluation
- Passage of the Jurisprudence Exam in three attempts
- 4 hours of continuing medical education in Anger Management

This recommendation is based on unprofessional conduct. **Ms. Southard seconded the motion.** During discussion, **Mr. Denton moved to amend the motion deleting the Jurisprudence Exam as a stipulation of the order. Dr. Snoots seconded the amendment. Mr. Denton and Dr. Snoots voted for the amendment. Mr. Gallardo, Dr. Simonson, Ms. Southard and Mr. Webb voted against the amendment. The amended motion failed. The original motion was then considered. All voted in favor. The original motion passed.**

Applicant #1689 appeared before the Committee, with counsel, in executive session. In open session, **Mr. Gallardo moved that the committee recommend to the full Board that the applicant be granted a physician in training permit. Mr. Webb seconded the motion. All voted in favor. The motion passed.**

Mr. Gallardo moved, Ms. Southard seconded, that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda item 4a. The motion passed. Dr. Arambula announced that the meeting would be closed for deliberations at 12:55 p.m. concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

Ms. Southard left the meeting at 2:11 p.m.

The Executive Session ended at 3:05 p.m.

Agenda Item 4a - continued

Applicant #1674 appeared before the Committee, with counsel, in executive session. In open session, Dr. Snoots moved that the committee recommend to the full Board that the applicant be privately referred to the Texas Physician Health Program (TPHP) and upon resolution with the TPHP be granted an unrestricted license. This recommendation is based on the inability to practice due to a mental/physical condition. Mr. Webb seconded the motion. All voted in favor. The motion passed.

Applicant #1668 appeared before the Committee, in executive session. In open session, **Mr. Webb** moved that the committee recommend to the full Board that the applicant be granted an unrestricted license. Mr. Denton seconded the motion. All voted in favor. The motion passed.

Applicant #1677 appeared before the Committee in executive session. In open session, **Mr. Gallardo moved that the applicant's appeal be denied. The motion failed for a lack of a second. Dr. Snoots moved that the applicant's appeal be granted and the applicant be granted a license, under a non-disciplinary Remedial Plan with the following conditions:**

• 4 hours of continuing medical education in Ethics

Mr. Webb seconded the motion. Dr. Snoots withdrew his motion and moved that the applicant be granted a license, under a non-disciplinary Remedial Plan with the following conditions:

• 4 hours of continuing medical education in Ethics

This recommendation is based on submitting a false statement to the Board. Mr. Webb seconded the motion. Mr. Gallardo voted against the motion. All others voted in favor. The motion passed.

Applicant #1681 appeared before the Committee, with counsel, in executive session. In open session **Mr**. **Denton moved that the committee recommend to the full Board that the applicant be granted a Physician in training permit. Mr. Gallardo seconded the motion. All voted in favor. The motion passed.**

Applicant #1687 appeared before the Committee, with counsel, in executive session. In open session, **Dr**. Simonson moved that the committee recommend to the full Board that the applicant be granted a Physician in training permit. Mr. Webb seconded the motion. All other voted in favor. The motion passed.

Item 4b - Proposed orders offered by the Executive Director –Ms. Knight reported on 13 physician licensure orders offered by the Executive Director and accepted by applicants. Mr. Gallardo moved to

recommend to the full Board that the orders be approved. Mr. Webb seconded. All voted in favor. The motion passed.

Item 4c – Physician licensure applicants to be licensed. There were 154 applicants who met all requirements to be considered for permanent licensure by the full Board. **Mr. Webb moved to recommend to the full Board that all 154 physician licensure applicants determined to meet eligibility requirements by staff be approved. Mr. Denton seconded the motion. All voted in favor. The motion passed.**

Item 4d – Surgical assistant licensure applicants to be licensed. There were 7 surgical assistant applicants who met all requirements to be considered for licensure by the full Board. **Mr. Gallardo moved to recommend to the full Board that all 7 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Dr. Simonson seconded the motion. All voted in favor. The motion passed.**

Agenda Item 4e - Acudetox applicants for certification - There were none

Agenda Item 5 – Report on physician licensure statistics. Ms. Knight reported that the third quarter of FY15 1,256 new physician licenses were issued compared to 1,273 in the third quarter of FY14. Ms. Knight also reported that the average time to complete physician licensure applications during the third quarter of FY15 was 35 days.

Agenda Item 6 - Discussion, recommendation, and possible action regarding cancellation of licenses by request for incomplete registration. There were none

Agenda Item 7a - Discussion, recommendation, and possible action regarding Nonprofit Health Organizations: Applicants for initial certification. There were 6 applications for initial certification as a Nonprofit Health Organization for approval. Mr. Webb moved to recommend to the full Board that the 6 requests for initial certification as a Nonprofit Health Organization be approved. Mr. Gallardo seconded. All voted in favor and the motion passed.

Agenda Item 7b - Discussion, recommendation, and possible action regarding Nonprofit Health Organizations: Requests for biennial recertification - There were 127 applications for biennial recertification as a Nonprofit Health Organization for approval. Mr. Gallardo moved to recommend to

the full Board that the 127 requests for biennial recertification as a Nonprofit Health Organization be approved. Mr. Webb seconded. All voted in favor and the motion passed.

Agenda Item 7c - Discussion, recommendation, and possible action regarding Nonprofit Health Organizations: Cancellation of organizations certified as Nonprofit Health Organizations – There were none

Agenda Item 8 - Discussion, recommendation, and possible action regarding the Ten Year Rule. Ms. Knight asked for direction regarding a request from the American Board of Pediatrics (ABP) regarding whether online proctoring of the Maintenance of Certification exam via a web camera would meet Board Rule regarding monitored, proctored exams. The Committee directed staff to do more research on the safeguards and effectiveness of online proctoring.

Agenda Item 9 - Discussion, recommendation, and possible action regarding Visiting Physician Temporary Permits. Ms. Pajak asked for direction in regards to the Visiting Physician Temporary Permit. Currently, the rules don't explicitly require that applicants for this permit be licensed in any jurisdiction. She also informed the Committee that the existing rules do not preclude a licensed Texas physician with a pending investigation from acting as a supervising physician. The Board directed to staff to bring proposed rule changes to the next meeting to address both of these issues.

Agenda Item 10 - Discussion, recommendation, and possible action regarding proposed amendments to board rules:

a. 171.3 – Physician in Training Permits

Mr. Gallardo moved to recommend to the full Board that the rule as presented be published in the Texas Register for public comment. Dr. Simonson seconded. All voted in favor. The motion passed.

Agenda Item 11 - There being no further business, the meeting was adjourned at 3:15 p.m.

Chapter 171 Post Graduate Training Programs Page 1 of 3 Proposed for Publication

171.3 Physician-in-Training Permits

(a) - (b) - unchanged

(c) Application for Physician-in-Training Permit.

(1) Application Procedures.

(A) Applications for a physician-in-training permit shall be submitted to the board no earlier than the 120th day prior to the date the applicant intends to begin postgraduate training in Texas to ensure the application information is not outdated. To assist in the expedited processing of the application, the application should be submitted as early as possible within the sixty-day window prior to the date the applicant intends to begin postgraduate training in Texas.

(B) The board may, in unusual circumstances, allow substitute documents where exhaustive efforts, on the applicant's part to secure the required documents, <u>are</u> [is] presented. These exceptions shall be reviewed by the board's executive director on a case-by-case basis.

(C) For each document presented to the board, which is in a foreign language, an official word-for-word translation must be furnished. The board's definition of an official translation is one prepared by a government official, official translation agency, or a college or university official, on official letterhead. The translator must certify that it is a "true translation to the best of his/her knowledge, that he/she is fluent in the language, and is qualified to translate." He/she must sign the translation with his/her signature notarized by a Notary Public. The translator's name and title must be typed/printed under the signature.

(D) The board's executive director shall review each application for training permit and shall approve the issuance of physician-in-training permits for all applicants eligible to receive a permit. The executive director shall also report to the board the names of all applicants determined to be ineligible to receive a permit, together with the reasons for each recommendation. The executive director may refer any application to a committee or panel of the board for review of the application for a determination of eligibility.

(E) An applicant deemed ineligible to receive a permit by the executive director may request review of such recommendation by a committee or panel of the board conducted in accordance with §187.13 of this title (relating to Informal Board Proceedings Relating to Licensure Eligibility within 20 days of written receipt of such notice from the executive director.

(F) If the committee or panel finds the applicant ineligible to receive a permit, such recommendation together with the reasons for the recommendation, shall be submitted to the board. The applicant shall be notified of the panel or committee's determination and given the option to appeal the determination of ineligibility to

the State Office of Administrative Hearings (SOAH) or accept the determination of ineligibility. [unless the applicant makes a written request for a hearing within 20 days of receipt of notice of the committee's or panel's determination.]

(i) An applicant has 20 days from the date the applicant receives notice of the board's determination of ineligibility to submit a written response to the Board electing one of the two options listed in subparagraph (F).

(ii) Applicant's failure to respond to the board's notice of a determination of ineligibility within 20 days shall be deemed acceptance by applicant of the board's ineligibility determination.

(iii) If the applicant timely notifies the board of applicant's intent to appeal the board's ineligibility determination to SOAH, a contested case before SOAH will be initiated only in accordance with §187.24 of this title (relating to Pleadings). Applicant shall comply with all other provisions relating to formal proceedings as set out in this title Chapter 187 Subchapter C (relating to Formal Board Proceedings at SOAH).

(iv) If the applicant does not timely take action as described in paragraph (F) or, prior to the initiation of a contested case at SOAH, withdraws their intent to appeal the board's ineligibility determination to SOAH, the committee's determination of ineligibility shall be deemed acceptance by applicant of the board's ineligibility determination. [The hearing shall be before an administrative law judge of the State Office of Administrative Hearings and shall comply with the Administrative Procedure Act, the rules of the State Office of Administrative Hearings and the board. The board shall, after receiving the administrative law judge's proposed findings of fact and conclusions of law, determine the eligibility of the applicant to receive a permit. A physician whose application to receive a permit is denied by the board shall receive a written statement containing the reasons for the board's action.]

(G) All reports and investigative information received or gathered by the board on each applicant are confidential and are not subject to disclosure under the Public Information Act, Government Code Chapter 552 and the Medical Practice Act, Texas Occupations Code §§155.007(g), 155.058, and 164.007(c). The board may disclose such reports and investigative information to appropriate licensing authorities in other states.

(H) All applicants for physician-in-training permits whose applications have been filed with the board in excess of one year will be considered expired.

(I) If the Executive Director determines that the applicant clearly meets all PIT requirements, the Executive Director or a person designated by the Executive Director, may issue a permit to the applicant, to be effective on the date of the reported first date of the training program without formal board approval, as authorized by \$155.002(b) of the Act.

(J) If the Executive Director determines that the applicant does not clearly meet all PIT requirements, a PIT may be issued only upon action by the board following a recommendation by the Licensure Committee, in accordance with \$155.007 of the Act (relating to Application Process) and \$187.13 of this title (relating to Informal Board Proceedings Relating to Licensure Eligibility). (K) If the Executive Director determines that the applicant is ineligible for a PIT for one or more reasons listed under subsection (b)(1)(A) and (C) - (E) of this section, the applicant may appeal that decision to the Licensure Committee before completing other licensure requirements for a determination by the Committee solely regarding issues raised by the determination of ineligibility. If the Committee overrules the determination of the Executive Director, the applicant may then provide additional information to complete the application, which must be analyzed by board staff and approved before a license may be issued.
