LICENSURE COMMITTEE MEETING MINUTES
VIDEO CONFERENCE MEETING
June 10, 2021

The meeting was called to order 9:34 a.m. by Roberto Martinez, M.D., Chair. Other Committee members present were Michael Cokinos, George De Loach, D.O., Kandace Farmer, D.O., Tomeka M. Herod, Jayaram B. Naidu, M.D.

Committee members absent were Arun Agarwal, Jeffrey L. Luna, M.D. and Satish Nayak, M.D.

Dr. Nayak entered the meeting at 9:45 a.m.

Dr. Luna entered the meeting at 9:58 a.m.

Dr. Luna left the meeting at 12:00 p.m.

Agenda Item 2 – Licensee requests.

There are none.

Mr. Cokinos moved, and Dr. Naidu seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Item 3a. The motion passed. Dr. Martinez announced that the meeting would be closed for deliberations at 9:38 a.m. concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

The Executive Session ended at 12:05 p.m. The Licensure Committee conducted hearings to review licensure applicants appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

Agenda Item 3a - Applicants appearing concerning eligibility.

Applicant #1794 appeared before the Committee, with counsel, in executive session. In open session, **Mr. Cokinos** moved that the committee recommend to the full Board that the applicant be determined ineligible for a license. This recommendation is due to repeated or recurring meritorious health care liability claims. **Dr. De Loach** seconded the motion. All voted in favor. The motion passed.

Applicant #2450 appeared before the Committee, with counsel, in executive session. In open session, **Ms. Herod** moved that the committee recommend to the full Board that the applicant be granted reissuance of their license subject to an Agreed Order due to a felony conviction related to health care fraud, disciplinary history with the Texas Medical Board and time out of active practice of medicine.

- **The Agreed Order will have the following conditions:**
 - **Applicant shall limit their medical practice, including any office and inpatient practice, to a group or an institutional setting approved in advance by the Executive Director of the Board. Applicant shall provide a copy of this Order to the group or institutional setting administrator.**
 - **The supervising physician will submit quarterly reports to include the applicant's ability to appropriately treat patients.**
 - **The Applicant may not supervise or delegate to mid-level practitioners.**

Dr. Naidu seconded the motion. All voted in favor and the motion passed.

Agenda Item 3b – Proposed orders offered by the Executive Director.

Ms. Unterborn reported on 7 Remedial Plans offered by the Executive Director and accepted by the applicants. After discussion **Dr. Farmer** moved to recommend to the full Board that the 7 Remedial Plans be approved. **Dr. De Loach** seconded the motion. All voted in favor and the motion passed.

Agenda Item 3c – Physician licensure applicants to be licensed.

Ms. Unterborn reported that there were 207 applicants who met all requirements to be considered for permanent licensure by the full Board. **Dr. De Loach** moved to recommend to the full Board that all 207 physician licensure applicants determined to meet eligibility requirements by staff be approved. **Mr. Cokinos** seconded the motion. All voted in favor and the motion passed.

Agenda Item 3d – Surgical Assistant licensure applicants to be licensed.

Ms. Unterborn reported that there were **4** surgical assistant applicants who met all requirements to be considered for licensure by the full Board. **Dr. Nayak moved to recommend to the full Board that all 4 surgical assistant applicants determined to meet eligibility requirements by staff be approved.** Dr. Farmer seconded the motion. All voted in favor and the motion passed.

Agenda Item 3e – Acudetox applicants to be certified.

Ms. Unterborn reported that there was **1** Acudetox Specialist applicant who met all requirements to be considered for certification by the full Board. **Ms. Herod moved to recommend to the full Board that the 1 Acudetox Specialist applicant determined to meet eligibility requirements by staff be approved.** Dr. De Loach seconded the motion. All voted in favor and the motion passed.

Agenda Item 4 – Report on Physician licensure statistics.

Ms. Unterborn reported that in Quarter 3 of FY20, 1738 new physician licenses were issued in an average processing time of 24 days. In Quarter 3 of FY21, 1908 new physician licenses were issued in an average processing time of 28 days.

Agenda Item 5a – Cancellation of licenses by request or for incomplete registration – Surgical Assistants.

There are none.

Agenda Item 5b – Cancellation of Licenses by request or for incomplete registration – Acudetox.

Ms. Unterborn reported that there were **9** Acudetox licenses for cancellation by request or for incomplete registration. **Dr. Farmer moved to recommend to the full Board that all 9 Acudetox licenses be cancelled.** Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Agenda Item 6a -Nonprofit Health Organizations - Applicants for Initial Certification.

Ms. Unterborn reported that there were **4** applicants for initial certification as a Nonprofit Health Organization for approval. **Dr. Naidu moved to recommend to the full Board that the 4 applicants for initial certification as a Nonprofit Health Organization be approved.** Dr. De Loach seconded the motion. All voted in favor and the motion passed.

Agenda Item 6b - Nonprofit Health Organizations - Requests for Biennial Recertification.

Ms. Unterborn reported that there were **5** requests for biennial recertification as a Nonprofit Health Organization for approval. **Ms. Herod moved to recommend to the full Board that the 5 applicants for requests for biennial recertification as a Nonprofit Health Organization be approved.** Dr. De Loach seconded the motion. All voted in favor and the motion passed.

Agenda Item 6c - Nonprofit Health Organizations – Cancellation of organizations certified as Nonprofit Health Organizations.

Ms. Unterborn reported that there were **82** applications for cancellation of certification as a Nonprofit Health Organization for approval. **Dr. Farmer moved to recommend to the full Board that the 82 cancellations of certification as a Nonprofit Health Organization be approved. Dr. De Loach seconded the motion. All voted in favor and the motion passed.**

Agenda Item 7– Discussion, recommendation and possible action regarding proposed amendments to Title 22 of the Texas Administrative Code.

There are none.

Agenda Item 8 – Adjourn.

There being no further business, **Mr. Cokinos moved to adjourn the meeting. Dr. Naidu seconded the motion. All voted in favor and the motion passed. The meeting was adjourned at 12:21 p.m.**
