

TEXAS MEDICAL BOARD
LICENSURE COMMITTEE MEETING MINUTES
November 6, 2014

The meeting was called to order 10:40 a.m. on November 6, 2014 by Chair, Paulette B. Southard. Committee members present were Michael Arambula, M.D.; Frank S. Denton; John D. Ellis, Jr.; John R. Guerra, D.O.; Robert B. Simonson, D.O.; Wynne M. Snoots, M.D.; and Timothy Webb.

Dr. Arambula moved, Dr. Snoots seconded, that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda items 2a and 2b. The motion passed. Ms. Southard announced that the meeting would be closed for deliberations at 10:41 a.m. concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

The Executive Session ended at 4:50 p.m.

The Licensure Committee conducted hearings to review applicants appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

Agenda Item 2a – Applicants for pain management certification

Applicant #1586 appeared before the Committee, with counsel, in executive session to appeal the Executive Director's determination of ineligibility for certification as a pain management clinic. In open session, **Dr. Snoots moved to recommend to the full Board that the renewal of the applicant's pain management certification be approved. Mr. Ellis seconded the motion. All voted in favor. The motion passed.**

Dr. Arambula moved to reconsider this applicant on the basis that it was an appeal of ineligibility and he would like to go on the record as opposed to the passed motion, as well as request that the Committee reconsider the original motion on the basis that it is inconsistent with the other determination made at this meeting. Mr. Denton seconded. Dr. Arambula, Mr. Denton and Mr. Webb voted to reconsider the original motion. Dr. Simonson, Dr. Snoots and Dr. Guerra voted

against reconsidering the motion. Ms. Southard voted in favor of the motion to reconsider. The motion passed.

Dr. Snoots moved again to grant the applicant's appeal of a denial of renewal of their pain management clinic certification. Dr. Simonson seconded the motion. The Committee members discussed whether the conditions of the applicant's Agreed Order disqualified the applicant from renewal of the pain management certification. **Dr. Simonson, Dr. Snoots, Dr. Guerra and Mr. Ellis voted in favor of the motion to grant applicant's appeal. Dr. Arambula, Mr. Webb, Mr. Denton and Ms. Southard voted against the motion to grant applicant's appeal. The motion failed.**

Mr. Denton moved to defer a decision and discuss the matter again at the February Licensure Committee Meeting. Mr. Webb seconded the motion. Dr. Arambula, Mr. Denton, Ms. Southard and Mr. Webb voted for the motion. Dr. Guerra, Dr. Simonson and Dr. Snoots voted against the motion. Mr. Ellis abstained. The motion passed.

Applicant #1618 appeared before the Committee, with counsel, in executive session on referral by the Executive Director for consideration of renewal of pain management clinic certification. In open session **Dr. Snoots moved to recommend to the full Board that the applicant be determined ineligible for renewal of the pain management clinic certification.** This recommendation is based on the applicant being under current investigation by the Board; and the applicant being subject to disciplinary action by the board for conduct that was a result of inappropriately prescribing, dispensing, administering, supplying, or selling a controlled substance. **Mr. Webb seconded the motion. All voted in favor. The motion passed.**

Agenda Item 2b - Applicants appearing concerning eligibility

Applicant #922 appeared before the Committee in executive session. In open session, **Mr. Webb moved that the committee recommend to the full Board that the applicant be granted a license subject to an Agreed Order with the following conditions:**

- **Public Reprimand**
- **Administrative Penalty in the amount of \$ 2000; and**
- **Practice limited to an institutional or group setting**

This recommendation is based on disciplinary action taken by a health care entity and submitting a false statement to the Board. **Dr. Snoots seconded the motion. All voted in favor. The motion passed.**

Applicant #1389 appeared before the Committee in executive session. In open session, **Mr. Denton** moved that the committee recommend to the full Board that the applicant's appeal is denied and the applicant is determined ineligible for a surgical assistant license. This recommendation is based on the applicant's failure to meet the requirements for substantial equivalence. **Dr. Simonson** seconded the motion. **Mr. Ellis** opposed. All remaining members voted in favor. The motion passed.

Applicant #1561 appeared before the Committee in executive session. In open session, **Dr. Arambula** moved that the committee recommend to the full Board that the applicant be privately referred to the Texas Physician Health Program (TPHP) and upon resolution with the TPHP the applicant will be granted a license under a non-disciplinary Remedial Plan with the following conditions:

- Completion of 8 hours of continuing medical education in ethics

“Resolution” for the purposes of the TPHP referral shall mean:

- 1) submitting to an evaluation by the Physician Health Program (“PHP”) no later than 30 days from the effective date of this private referral, as applicable; and
- 2) following all recommendations made as a result of the evaluation, if any, including signing a contract with PHP; and
- 3) furnishing notice to the board of resolution as set forth above.

This recommendation is based on the applicant submitting a false statement to the Board. **Mr. Webb** seconded. All voted in favor. The motion passed.

Applicant #1585 appeared before the Committee in executive session. In open session, **Mr. Webb** moved that the committee recommend to the full Board that the applicant be determined ineligible for a provisional license. This recommendation is based on the applicant's failure to meet the active practice of medicine. **Mr. Ellis** seconded the motion. All voted in favor. The motion passed.

Applicant #1587 appeared before the Committee, with counsel, in executive session. In open session, **Mr. Denton** moved that the committee recommend to the full Board that the applicant be granted a license subject to an Agreed Order for a period of 10 years under the following terms and conditions:

- Abstain from consumption of prohibited substances
- Participate in the Board's drug testing program
- Attend AA 2 times per week

This recommendation is based on the applicant's unprofessional conduct relating to their violation of a PHP agreement while under a physician in training permit. **Dr. Simonson seconded the motion. All voted in favor. The motion passed.**

Applicant #1592 appeared before the Committee, with counsel, in executive session. In open session, **Mr. Webb moved that the committee recommend to the full Board that the applicant be determined ineligible for a license.** This recommendation is based on unprofessional conduct and conviction of a misdemeanor. **Dr. Arambula seconded the motion. All voted in favor. The motion passed.**

Applicant #1598 appeared before the Committee, with counsel, in executive session. In open session, **Mr. Ellis moved that the committee recommend to the full Board that the applicant be granted a license, under a non-disciplinary Remedial Plan with the following conditions:**

- **Participation in the University of Texas Dallas Physician Coaching Program**

This recommendation is based on unprofessional conduct; disciplinary action taken by a health care entity; and submitting a false statement to the Board. **Dr. Snoots seconded the motion. All voted in favor. The motion passed.**

Applicant #1603 appeared before the Committee, with counsel, in executive session. In open session **Dr. Arambula moved that the committee recommend to the full Board that the applicant be granted a license, under a non-disciplinary Remedial Plan with the following conditions:**

- **Participation in the University of Texas Dallas Physician Coaching Program**

This recommendation is based on unprofessional conduct; disciplinary action taken by a health care entity; and submitting a false statement to the Board. **Mr. Ellis seconded the motion. Dr. Simonson recused himself from the vote. All remaining members voted in favor. The motion passed.**

Applicant #1607 appeared before the Committee in executive session. In open session, **Mr. Denton moved that the committee recommend to the full Board that the applicant's appeal is denied and the original offer of a Remedial Plan stands, with one correction to the findings in the original offer which indicates applicant was terminated from their program.** This recommendation for a Remedial Plan is based on the applicant's submission of a false statement on their licensure application by failing to report additional training requirements during their postgraduate training program. **Dr. Snoots seconded the motion. All voted in favor. The motion passed.**

Applicant #1609 appeared before the Committee, with counsel, in executive session. In open session, **Dr. Arambula moved that the committee recommend to the full Board that the applicant is denied and the original offer of a Remedial Plan stands, with one correction to the statutory basis for the Remedial Plan from unprofessional conduct to peer review.** This recommendation for a Remedial Plan is based on disciplinary action taken by a health care entity. **Mr. Webb seconded the motion. All voted in favor. The motion passed.**

Applicant #1610 appeared before the Committee, with counsel, in executive session. In open session, **Mr. Denton moved that the committee recommend to the full Board that the applicant's appeal of the of the Executive Director's denial of the applicant's request for:**

- **exemption from the Ten Year Rule and**
- **sponsorship to take the SPEX exam**

be denied and the appeal of the Executive Director's determination of ineligibility be denied. This recommendation is based on the applicant's conviction of a felony/misdemeanor, unprofessional conduct, failure to practice medicine within the standard of care, being disciplined by another state, disciplinary action taken by a health care entity, and time out of practice. **Dr. Snoots seconded the motion. All voted in favor. The motion passed.**

Item 2c - Proposed orders offered by the Executive Director –Ms. Knight reported on 17 physician licensure orders, 2 physician in training orders and 1 surgical assistant order offered by the Executive Director and accepted by applicants. **Mr. Webb moved to recommend to the full Board that the orders be approved. Dr. Snoots seconded. All voted in favor. The motion passed.**

Item 2d – Physician licensure applicants to be licensed. There were 183 applicants who met all requirements to be considered for permanent licensure by the full Board. **Mr. Webb moved to recommend to the full Board that all 183 physician licensure applicants determined to meet eligibility requirements by staff be approved. Dr. Arambula seconded the motion. All voted in favor. The motion passed.**

Item 2e – Surgical assistant licensure applicants to be licensed. There were 9 surgical assistant applicants who met all requirements to be considered for licensure by the full Board. **Mr. Webb moved to recommend to the full Board that all 9 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Mr. Ellis seconded the motion. All voted in favor. The motion passed.**

Agenda Item 2f – Acudetox applicants for certification – There were 8 acudetox applicants who met all requirements to be considered for certification by the full board. **Dr. Snoots moved to recommend to the full Board that the 8 acudetox applicants determined to meet eligibility requirements by staff be approved. Mr. Webb seconded the motion. All voted in favor. The motion passed.**

Agenda Item 3 – Report on physician licensure statistics. Ms. Knight reported that the average time to complete applications for physician licensure for all of FY 14 was 41 days. Ms. Knight also reported the total number of new physicians licensed in FY14 was 3,994, an 11% increase from FY13. In addition, as directed by the Licensure Committee in June 2014 Ms. Knight also provided statistics on the number of Ross University graduates who were determined ineligible due unaccredited clerkships. In FY 13 a total of 122 applicants were determined ineligible due to various statutory reasons. Ross Graduates who were determined ineligible due to unaccredited clerkships accounted for 14 of those applicants or 11% of those who were found to be ineligible. For FY14 there were 103 total applicants determined ineligible, 20 of which were Ross grads, or 19%.

Agenda Item 4 - Discussion, recommendation, and possible action regarding cancellation of licenses by request for incomplete registration. There were none

Agenda Item 5a - Discussion, recommendation, and possible action regarding Nonprofit Health Organizations: Applicants for initial certification. There were 18 applications for initial certification as a Nonprofit Health Organization for approval. **Dr. Arambula moved to recommend to the full Board that the 18 requests for initial certification as a Nonprofit Health Organization be approved. Mr. Webb seconded. All voted in favor and the motion passed.**

Agenda Item 5b - Discussion, recommendation, and possible action regarding Nonprofit Health Organizations: Requests for biennial recertification - There were 3 applications for biennial recertification as a Nonprofit Health Organization for approval. **Dr. Arambula moved to recommend to the full Board that the 3 requests for biennial recertification as a Nonprofit Health Organization be approved. Mr. Denton seconded. All voted in favor and the motion passed.**

Agenda Item 5c - Discussion, recommendation, and possible action regarding Nonprofit Health Organizations: Cancellations of organizations certified as Nonprofit Health Organizations - There were 3 Nonprofit Health Organizations for cancellation. **Dr. Arambula moved to recommend to the**

full Board that the certification of the 3Nonprofit Health Organizations be cancelled. Mr. Webb seconded. All voted in favor and the motion passed

Agenda Item 6 – Discussion, recommendation, and possible action regarding registration/renewal forms– Ms. Knight presented the current registration/renewal questions for the Committee to review. No changes were made.
