TEXAS MEDICAL BOARD MINUTES OF THE DISCIPLINARY PROCESS REVIEW COMMITTEE August 23, 2018

Acting Chair James "Scott" Holliday, D.O., called the meeting to order at 9:53 a.m. Other members present were Sherif Z. McNeese, M.D. Kerri L. Crosby, P.A., Physician Assistant Board liaison attended the meeting.

Staff members present were Stephen Brint Carlton, J.D. Executive Director, Robert Bredt, M.D., Medical Director, Scott Freshour, J.D. General Counsel and various other staff.

Agenda Item #2. Discussion, recommendation, and possible action regarding referrals from the Texas Physician Health Program (PHP).

It was announced by Mr. Karney that there were no TXPHP cases to be presented to the DPRC under Agenda Item #2.

Agenda Item #3. Reports and discussion regarding Texas Physician Health Program.

This was an informational report item only and no action was taken and no vote was necessary.

Agenda Item #4. Discussion, recommendation, and possible action regarding renewals involving impaired licensees.
