

**TEXAS MEDICAL BOARD  
LICENSURE COMMITTEE MEETING MINUTES  
VIDEO CONFERENCE MEETING  
December 3, 2020**

**The meeting was called to order 9:49 a.m.** by Linda Molina, J.D., Chair. Other Committee members present were Arun Agarwal, Michael Cokinos, George De Loach, D.O., Tomeka M. Herod, Roberto Martinez, M.D. and Jayaram B. Naidu, M.D.

Committee members absent were Kandace Farmer, D.O., Jeffrey L. Luna, M.D. and Satish Nayak, M.D.

**Dr. Martinez moved and Mr. Agarwal seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Items 2 and 3a. The motion passed.** Ms. Molina announced that the meeting would be closed for deliberations at **9:51 a.m.** concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

**The Executive Session ended at 3:11 p.m.** The Licensure Committee conducted hearings to review licensure applicants appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the requests and applications.

**Agenda Item 2 – Licensee requests.**

**Applicant #2442** appeared before the Committee in executive session. In open session, **Mr. Cokinos moved that the committee recommend to the full Board that the licensee’s request to return their license to active status be granted and their license be returned to active status. Dr. Naidu seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 3a - Applicants appearing concerning eligibility.**

**Applicant #2441** appeared before the Committee in executive session. In open session, **Dr. Naidu moved that the committee recommend to the full Board that the applicant be granted an unrestricted license. Dr. De Loach seconded the motion. All voted in favor and the motion passed.**

**Applicant #2438** appeared before the Committee in executive session. In open session, **Ms. Herod** moved that the committee recommend to the full Board that the applicant be granted an unrestricted license. **Mr. Cokinos** seconded the motion. All voted in favor and the motion passed.

**Applicant #1545** appeared before the Committee, with counsel, in executive session. In open session, **Dr. Naidu** moved that the committee recommend to the full Board that the the applicant be granted an unrestricted license. **Dr. De Loach** seconded the motion. All voted in favor and the motion passed.

**Applicant #2287** appeared before the Committee, with counsel, in executive session. In open session, **Dr. De Loach** moved that the committee recommend to the full Board that the the applicant be granted an unrestricted license. **Dr. Naidu** seconded the motion. All voted in favor and the motion passed.

**Applicant #2444** appeared before the Committee, with counsel, in executive session. In open session, **Dr. Naidu** moved that the committee recommend to the full Board that the Applicant's appeal of the Executive Director's determination of ineligibility be granted. Further, he moved that the committee recommend to the full Board that a determination be deferred until such time the Applicant successfully completes a 90 day mini-residency to remedy their active practice issue. A proposal for the mini-residency must be received within 45 days of this meeting and reviewed and approved by the Board's Medical Director and Executive Director. If not received within 45 days of this meeting, the Applicant's application will be considered withdrawn.

The proposal shall include the preceptor's identity, Applicant's duties and responsibilities throughout the mini-residency, the practice setting, the types of cases and patients that will be treated, and the number of patients the practice sees on a daily basis. The proposal must also include how many hours per week the Applicant will be practicing clinically, what supervision will consist of, and how the Applicant will be evaluated.

The preceptor must submit a report to the Board at the conclusion of the mini-residency. Upon proof of satisfactory completion of the mini-residency with no issues reported by the preceptor, the Executive Director may direct that the Applicant be granted an unrestricted license. **Dr. De Loach** seconded the motion. All voted in favor and the motion passed.

The Licensure Committee recessed the meeting at 3:13 p.m.

**At 3:14 p.m. Dr. Zaafran appointed a Special Licensure Committee to hear Agenda Item 08. Specially appointed committee members present were Manuel Quinones, Jr., M.D., Temporary Committee Chair; Sharon Barnes; James Distefano, D.O.; Robert Gracia; Jason Tibbels, M.D.; David Vanderweide, M.D.; and Sherif Zaafran, M.D. Standing Licensure Committee members were excused temporarily from the meeting.**

**Dr. Distefano moved and Dr. Vanderweide seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Item 8. The motion passed. Dr. Quinones announced that the meeting would be closed for deliberations at 3:20 p.m. concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.**

**The Executive Session ended at 5:20 p.m.** The Licensure Committee conducted hearings to review licensure applicants appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the requests and applications.

**Agenda Item 8 - Discussion, recommendation and possible action regarding pending business.**

**Applicant #2427** appeared before the Committee in executive session. In open session, **Ms. Barnes moved that the committee recommend to the full Board that a determination be deferred until such time the applicant completes a 1 year mini-residency. The proposal for the mini-residency must be received within 60 days of this meeting and reviewed and approved by the Board's Medical Director and Executive Director. If not received within 60 days of this meeting, the Applicant's application will be considered withdrawn.**

**The proposal shall include the preceptor's identity, Applicant's duties and responsibilities throughout the mini-residency, the practice setting, the types of cases and patients that will be treated, and the number of patients the practice sees on a daily basis. The proposal must also include how many hours per week the Applicant will be practicing clinically, what supervision will consist of, and how the Applicant will be evaluated.**

**The preceptor shall send monthly reports for review by the Board's Medical Director.**

**The Applicant may appear before this specially appointed Licensure Committee 6 months after the start of this mini-residency for review by the Licensure Committee of their progress. If Applicant's progress is**

satisfactory to the specially appointed Licensure Committee, the Committee may, at that time, modify the recommendation for a 1 year mini-residency.

**Mr. Gracia seconded the motion. All voted in favor and the motion passed.**

**Dr. Zaafran excused the specially appointed Committee members and recalled the standing Licensure Committee members. The Licensure Committee resumed their meeting at 5:33 p.m.** Committee members present were Linda Molina, J.D., Chair, Michael Cokinos, George De Loach, D.O., Tomeka M. Herod, Roberto Martinez, M.D. and Jayaram B. Naidu, M.D.

Committee members absent were Arun Agarwal, Kandace Farmer, D.O., Jeffrey L. Luna, M.D. and Satish Nayak, M.D.

**Ms. Molina moved and Dr. Naidu seconded that the Committee close the meeting to the public and continue in Executive Session for continued deliberations concerning Agenda Item 3a. The motion passed.** Ms. Molina announced that the meeting would be closed for deliberations at **5:35 p.m.** concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

### **Agenda Item 3a.**

**Applicant #2443** appeared before the Committee in executive session to appeal the Executive Director's determination of ineligibility. In open session, **Mr. Cokinos moved that the committee recommend to the full Board that the Applicant's appeal be denied due to failure to demonstrate compliance with applicable statutory requirements for licensure in Texas. Dr. Naidu seconded the motion. All voted in favor and the motion passed.**

**Applicant #2265** appeared before the Committee in executive session. In open session, **Ms. Molina moved that the committee recommend to the full Board that the Applicant's be determined ineligible for reissuance of their license due to the Applicant's criminal history, disciplinary history, time out of active practice, and failure to meet the requirements of Section 164.151(c) of the Texas Occupations Code. Dr. Martinez seconded the motion. All voted in favor. The motion passed.**

**Applicant #2267** appeared before the Committee, with counsel, in executive session. In open session, **Dr. Martinez** moved that the committee recommend to the full Board that the Applicant be granted reissuance of their license subject to an Agreed Order due to the Applicant's disciplinary history, time out of active practice, and impairment.

- **The Agreed Order will have the following conditions:**
  - **Public referral to the Texas Physician's Health Program**
  - **Applicant shall limit their medical practice, including any office and inpatient practice, to a group or an institutional setting approved in advance by the Executive Director of the Board. Applicant shall provide a copy of this Order to the group or institutional setting administrator.**
  - **Applicant shall not prescribe Schedule II or III drugs, except to treat substance use disorder.**

**Ms. Herod** seconded the motion. All voted in favor. The motion passed.

**Applicant #1988** appeared before the Committee, with counsel, in executive session. In open session, **Ms. Herod** moved that the committee recommend to the full Board that the Applicant's appeal of the Executive Director's determination of ineligibility be denied due to the Applicant's disciplinary history, time out of active practice and failure to meet the requirements of Section 164.151(c) of the Texas Occupations Code.

**Mr. Cokinos** seconded the motion. All voted in favor. The motion passed.

#### **Agenda Item 3b – Proposed orders offered by the Executive Director.**

Ms. Unterborn reported on **1 Agreed Order and 1 Remedial Plan** offered by the Executive Director and accepted by the applicants. After discussion **Ms. Herod** moved to recommend to the full Board that the **1 Agreed Order and 1 Remedial Plan** be approved. **Dr. Naidu** seconded the motion. All voted in favor and the motion passed.

#### **Agenda Item 3c – Physician licensure applicants to be licensed.**

Ms. Unterborn reported that there were **148** applicants who met all requirements to be considered for permanent licensure by the full Board. **Ms. Molina** moved to recommend to the full Board that all **148** physician licensure applicants determined to meet eligibility requirements by staff be approved. **Dr. De Loach** seconded the motion. All voted in favor and the motion passed.

**Agenda Item 3d – Surgical Assistant licensure applicants to be licensed.**

Ms. Unterborn reported that there were **9** surgical assistant applicants who met all requirements to be considered for licensure by the full Board. **Mr. Cokinos moved to recommend to the full Board that all 9 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Dr. Martinez seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 3e – Acudetox Specialist applicants to be certified.**

Ms. Unterborn reported that there were **1** Acudetox Specialist applicant who met all requirements to be considered for certification by the full Board. **Dr. Naidu moved to recommend to the full Board that the 1 Acudetox Specialist applicant determined to meet eligibility requirements by staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 4 – Report on Physician licensure statistics.**

Ms. Unterborn reported that in Quarter 1 of FY20, 814 new physician licenses were issued in an average processing time of 37 days. In Quarter 1 of FY21, 840 new physician licenses were issued in an average processing time of 38 days.

**Agenda Item 5a – Cancellation of licenses by request or for incomplete registration – Surgical Assistants.**
