



TEXAS PHYSICIAN ASSISTANT BOARD LICENSURE COMMITTEE MEETING MINUTES

March 6, 2015

The meeting was called to order at 9:08 a.m. by the Chair, Teralea Jones, PA-C. Committee members present were Jason P. Cooper, PA-C, and Felix Koo, M.D.

Agenda Item 2 – Discussion, recommendation, and possible action regarding licensure applicants referred to the Licensure Committee by the Executive Director for determination of eligibility of licensure.

Applicant #1628 appeared before the Committee, with counsel, on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. **Mr. Cooper moved to recommend to the full Board that the applicant be granted a Texas physician assistant license under an Agreed Order for a period of two years, subject to the following terms and conditions:**

- **Quarterly Reports from Supervising Physician**
- **Continue to comply with any requirements of the Texas Physician Health Program**
- **No petition for modification allowed**
- **Auto termination upon successful completion of supervising physician reporting requirements**

Factors contributing to this recommendation include the applicant's alcohol related criminal history, impairment history, and recent sobriety date. **Dr. Koo seconded the motion. All voted in favor. The motion passed.**

Agenda Item 3 - Discussion, recommendation, and possible action regarding review of Physician Assistant applications for permanent licensure. There were 135 applicants and 6 re-licensure applicants who met all requirements to be considered for permanent licensure by the full Board. **Dr. Koo moved to recommend to the full board that all 135 applicants and 6**

relicensure applicants be approved for permanent licensure. Mr. Cooper seconded the motion. All voted in favor and the motion passed.

Agenda Item 4 – Proposed Orders Offered by the Executive Director – There were none

Agenda Item 5 - Report on physician assistant licensure process statistics – Ms. Knight reported that 340 PA licenses were issued in the first half of Fiscal Year 2015 and were completed in an average of 16 days. Ms. Knight also reported this is a 32% increase in physician assistants licensed in the first half of Fiscal Year 2014.
