June 11, 2020

The meeting was called to order 10:29 a.m. by Chair, Linda Molina, J.D. Other Committee members present

were George De Loach, D.O., Kandace Farmer, D.O., Tomeka L. Herod, Roberto Martinez, M.D., Jayam B.

Naidu, M.D. and Satish Nayak, M.D.

Committee members absent were Arun Agarwal, Michael Cokinos, and Jeffrey L. Luna, M.D.

Dr. Martinez moved and Dr. De Loach seconded that the Committee close the meeting to the public and

continue in Executive Session for deliberations concerning Agenda Item 3a. The motion passed. Ms. Molina

announced that the meeting would be closed for deliberations at 10:29 a.m. concerning licensure applications and

the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and

155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any

decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any

executive session will be made.

Mr. Cokinos entered the meeting at 10:32 a.m.

The Executive Session ended at 12:52 p.m. The Licensure Committee conducted hearings to review licensure

applicants appearing concerning eligibility. The hearings were conducted in Executive Session. Following the

hearings, the Committee reconvened and considered the requests and applications.

Agenda Item 2 – Licensee requests.

There are none.

Agenda Item 3a - Applicants appearing concerning eligibility.

Applicant #2399 appeared before the Committee in executive session. In open session, Dr. De Loach moved

that the committee recommend to the full Board that the applicant's request for reissuance of their license

be granted. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Applicant #2391 appeared before the Committee in executive session. In open session, **Dr. Naidu moved that** the committee recommend to the full Board that the applicant's appeal of the determination of ineligibility be denied. Ms. Herod seconded the motion. All voted in favor and the motion passed.

Agenda Item 3b – Proposed orders offered by the Executive Director.

Ms. Unterborn reported on **5 Remedial Plans** offered by the Executive Director and accepted by the applicants. After discussion **Dr. Farmer moved to recommend to the full Board that the 5 Remedial Plans be** approved. **Dr. Martinez seconded the motion. All voted in favor and the motion passed.**

Agenda Item 3c – Physician licensure applicants to be licensed.

Ms. Unterborn reported that there were 174 applicants who met all requirements to be considered for permanent licensure by the full Board. Dr. Nayak moved to recommend to the full Board that all 174 physician licensure applicants determined to meet eligibility requirements by staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Agenda Item 3d – Surgical Assistant licensure applicants to be licensed.

Ms. Unterborn reported that were 8 surgical assistant applicants who met all requirements to be considered for licensure by the full Board. Mr. Cokinos moved to recommend to the full Board that all 8 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Dr. Martinez seconded the motion. All voted in favor and the motion passed.

Agenda Item 3e – Acudetox Specialist applicants to be certified.

Ms. Unterborn reported that there were 2 Acudetox Specialist applicants who met all requirements to be considered for certification by the full Board. Ms. Herod moved to recommend to the full Board that the 2 Acudetox Specialist applicants determined to meet eligibility requirements by staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Agenda Item 4 – Report on Physician licensure statistics.

Ms. Unterborn reported that in Quarter 3 of FY19, 1,666 new physician licenses were issued in an average processing time of 32 days. In Quarter 3 of FY20, 1738 new licenses were issued in an average processing time of 24 days.

Agenda Item 5a – Cancellation of licenses by request or for incomplete registration – Surgical Assistants. There are none.

Agenda Item 5b – Cancellation of Licenses by request or for incomplete registration – Acudetox.

Ms. Unterborn reported that were 4 Acudetox Specialist licenses for cancellation by request or for incomplete registration. Dr. Nayak moved to recommend to the full Board that all 4 Acudetox Specialist licenses licenses be cancelled. Ms. Herod seconded the motion. All voted in favor and the motion passed.

Agenda Item 6a -Nonprofit Health Organizations - Applicants for Initial Certification.

Ms. Unterborn reported that were 12 applicants for initial certification as a Nonprofit Health Organization for approval. Dr. Martinez moved to recommend to the full Board that the 12 applicants for initial certification as a Nonprofit Health Organization be approved. Dr. Farmer seconded the motion. All voted in favor and the motion passed.

Agenda Item 6b - Nonprofit Health Organizations - Requests for Biennial Recertification. Ms. Unterborn reported that were 15 requests for biennial certification as a Nonprofit Health Organization for approval. Mr. Cokinos moved to recommend to the full Board that the 15 requests for biennial certification as a Nonprofit Health Organization be approved. Dr. De Loach seconded. All voted in favor and the motion passed.

Agenda Item 6c - Nonprofit Health Organizations – Cancellation of organizations certified as Nonprofit Health Organizations. There are none.

Agenda Item 7– Discussion, recommendation and possible action regarding proposed amendments to Title 22 of the Texas Administrative Code. There are none.
