Dr. Zeitler moved, and Mr. Baucom seconded; the motion passed at 11:17 a.m. to go into Executive Session deliberations concerning disciplinary action, investigative information, peer review information, and rehabilitation orders under the authority of The Medical Practice Act Sections 152.009, 160.006 through .008, 164.007(c), and 164.202 & .203, Occupations Code. Open session resumed at 2:44 p.m. and it was announced that no action was taken during executive session. A certified agenda of the executive session was made.
