



TEXAS STATE BOARD OF ACUPUNCTURE EXAMINERS

LICENSURE COMMITTEE MEETING MINUTES

May 10, 2019

The meeting was called to order at 9:15 a.m. by the Chair, Allen Cline, L.Ac. Committee members present were Rachelle Webb, L.Ac. and Grant E. Weidler, L.Ac.

Committee member absent was Jeremy Wiseman, M.D.

Agenda Item 2 – Discussion, recommendation, and possible action regarding applicants appearing concerning eligibility.

Applicant #2300 appeared before the Committee to appeal the Executive Director's determination that the applicant work under a 12 month supervised temporary license or complete 240 hours of remedial education at an acceptable acupuncture school in order to demonstrate compliance with Board rule 183.4(9)(A) regarding active practice as an acupuncturist. The applicant presented a brief summary and the Committee members asked questions. **Ms. Webb moved that the committee recommend to the full Board that the applicant's appeal be granted and the applicant work under a 6 month supervised temporary license. Mr. Weidler seconded the motion. All voted in favor. The motion passed.**

Agenda Item 3 – Discussion, recommendation, and possible action regarding applicants for a Texas Acupuncture License.

Ms. Johnston reported that there were 19 applicants who met all requirements to be considered for permanent licensure by the full Board. Ms. Webb moved to recommend to the full board that the 19 acupuncture licensure applicants determined to meet eligibility
