Texas Medical Radiologic Technology Board LICENSURE COMMITTEE MEETING MINUTES

November 1, 2019

The meeting was called to order at 9:17 a.m. by Ms. Flanagan. Committee members present were Nicholas M. Beckmann, M.D., Anthony "Tony" Jaso and Carol Waddell, MRT.

Agenda Item 2 - Applicants appearing concerning eligibility.

Applicant #2351 appeared on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, Ms. Waddell moved that the applicant be placed on the Non-Certified Radiologic Technician Registry. Mr. Jaso seconded the motion. Ms. Waddell, Mr. Jaso and Ms. Flanagan voted in favor. Dr. Beckman voted nay. The motion passed.

Applicant #2350 appeared before the Committee to appeal the Executive Director's determination that the applicant be required to shadow a licensed Medical Radiology Technician or practitioner for at least three months as directed by the out of practice matrix that was approved by the Licensure Committee.

Mr. Jaso moved that the Committee recommend to the full Board that the Applicant's appeal be granted contingent upon the following conditions:

- The proposed supervising Noncertified Radiologic Technician (NCT) must submit a curriculum vitae which outlines their experience in the field, including a letter of recommendation from the supervising NCT's current employer.
- A copy of the supervising NCT's certificate confirming completion of an approved NCT program.
- Staff completion of background checks on the proposed supervising NCT.

Upon completion of these items the Executive Director may approve the applicant to be placed on the on the Non-Certified Radiologic Technician Registry. All voted in favor and the motion passed.

Applicant #2316 appeared on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Dr. Beckmann moved**

that the applicant be placed on the Non-Certified Radiologic Technician Registry. Ms. Waddell seconded the motion. All voted in favor and the motion passed.

Applicant #2352 did not appear before the Committee. Ms. Flanagan moved, and Mr. Jaso seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Applicant #2352. The motion passed. Dr. Beckmann announced that the meeting would be closed for deliberations at 10:03 a.m. under the authority of Texas Government Code Chapter 551.071, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made. The executive session ended at 10:39 a.m.

In open session, Ms. Waddell moved to defer a determination until such time that applicant #2352 appears before the Committee. The applicant's application will be extended to allow for his mandatory appearance at the February 2020 Board meeting. Dr. Beckmann seconded the motion. All voted in favor. The motion passed.

Further, Mr. Jaso directed staff to initiate an investigation on the program completed by the applicant based on concerns arising from the information presented as part of the applicant's application.

Agenda Item 3 - Proposed licensure agreed orders or remedial plans offered by the Executive Director. Ms. Johnston reported on 3 Agreed Orders offered by the Executive Director and accepted by applicants. Mr. Jaso moved that the 3 Agreed Orders be approved. Dr. Beckmann seconded. All voted in favor. The motion passed.

Agenda Item 4 – There being no further business, Ms. Waddell moved that the meeting be adjourned. Dr. Beckmann seconded. All voted in favor. The meeting was adjourned at 10:42 a.m.
