LICENSURE COMMITTEE MEETING MINUTES

October 10, 2014

The meeting was called to order at 8:40 a.m. by the Chair, Allen Cline, L.Ac. Committee members present were Raymond J. Graham, and Rachelle Webb, L.Ac.

Agenda Item 2 – Discussion, recommendation, and possible action regarding applicants for a Texas Acupuncture License: There were 17 licensure applicants who met all requirements to be considered for acupuncture licensure by the Texas State Board of Acupuncture Examiners (TSBAE). **Ms. Webb moved, Mr. Graham seconded and the motion passed to recommend to the full board that the 17 licensure applicants be approved for licenses and that their names be listed as part of the minutes of this Committee.**
