MINUTES OF THE DISCIPLINARY PROCESS REVIEW COMMITTEE

Agenda Item #2. Texas Physician Health Program (TXPHP).

A. Discussion, recommendation, and possible action regarding referrals.

Dr. Bhatia moved and Ms. Morgan seconded to accept the referral of Case No. 23-0402 PIT MD and refer the participant back to TXPHP should they apply for licensure in the future. The motion carried.

Ms. Troncoso moved and Ms. Barnes seconded to accept the referral of Case No. 24-0303 MD. The motion carried.
