# Message from the TMB President

## Legislative Session Summary



On June 2, 2025, the Texas Legislature concluded the regular meeting of the 89<sup>th</sup> legislative session. During the session, Board staff monitored hundreds of bills that could affect Board operations, Board staff, or TMB licensees.

This session saw the enactment of several bills that establish new licensure pathways,

enhance enforcement efforts, and increase licensee accountability through new continuing medical education (CME) requirements.

I would like to take this opportunity to highlight just a few bills impacting our licensees.

## HB 2038 - The DOCTOR Act

This **bill** creates a new pathway to licensure for internationally trained doctors allowing them a route to be licensed based on completion of a post-graduate training program in their home country. International applicants would work under a provisional license for four years in specific facilities and locations before being eligible for a full, unrestricted license. This bill also creates a new license type – a Physician Graduate license – for medical school graduates who do not match into a residency program. This license enables the state to utilize a physician graduate's medical education and knowledge under the supervision of a licensed physician. Each initiative outlined in this bill aims to enhance access to healthcare by increasing the number of providers.

## SB 31 – The Life of the Mother Act

This **bill** further clarifies the law surrounding abortion procedures in Texas and specifically requires TMB to make

available one or more approved courses – one free of charge – regarding the laws relating to pregnancy-related medical emergencies.

### SB 912

This **bill** requires state agencies who license healthcare practitioners to establish a continuing education (CE) tracking system to verify compliance with CE requirements prior to renewal.

## SB 2480

This **bill** ensures that all TMB licensees have equal access to the Texas Physician Health Program (TXPHP) and expands the National Practitioner Data Bank (NPDB) continuous query requirement to all license types ensuring every licensee receives the same level of oversight.

Aside from the aforementioned bills, legislation was also passed creating new CME requirements related to nutrition and metabolic health (SB 25) and forensic evidence collection (HB 47), enacting stricter regulatory measures for elective IV therapy (HB 3749), and establishing more streamlined pathways to licensure for military servicemembers and their families (HB 879, HB 5629, SB 1818).

Board staff have compiled a more comprehensive list of bills that may be of particular interest to our licensee community. That list includes links to the bill language for your convenience and can be found **here**.

Many of these bills require the Board to adopt rules for implementation and efforts are already underway to identify what rules are needed. Although the Board strives to implement legislation as promptly as possible, the rulemaking process can take time, which means that a bill's effective date is not necessarily an indicator of when the policy will take effect. It is simply the earliest possible date a policy can launch. One of the best ways for interested parties to stay informed on rulemaking activities is by tuning into this newsletter. The Board always publishes proposed rules and information on how to comment on those rules in the newsletter as well as on our website.

Additionally, I would highly recommend that interested parties sign up to receive e-mail notifications directly from the Texas Secretary of State's Office so that you are informed the moment TMB submits a proposed rule to the Texas Register for public comment. In general, this service allows individuals to choose agencies they wish to receive email notification about, and these emails contain information about proposed, adopted, withdrawn and emergency rule submissions accepted for filing, including rule number(s), type of action, and Texas Register issue date. To receive email notification, contact the Texas Register at 512-463-5561 or by email.

In terms of the budget, the Board did receive some of its requests. Significant achievements included securing funding for a new Ombudsman function within the agency, as well as obtaining funds for several additional full-time equivalent (FTE) positions. The agency is currently exploring how to best leverage the newly appropriated resources to get the greatest return and meet our core mission.

I want to extend a sincere thank you to Board staff for their efforts to support the Legislature in their policy discussions this session. I'd also like to thank the Legislature for their continued support of TMB. The Board looks forward to continuing to work with lawmakers during the interim to implement their legislation and identify further efficiencies to benefit our licensees and the public that depend on us.

On a personal note, on behalf of the entire agency, I want to offer my deepest condolences to all the families who lost loved ones in the flooding these past couple of weeks in Texas. Following the Governor's declaration of a State of Emergency, the Texas Medical Board has been prepared to facilitate any necessary measures to ensure families receive appropriate care. This includes ensuring that all required licensees are available to provide care efficiently and promptly, as well as issuing temporary licensure for out-ofstate physicians who may be needed during this crisis.

As always, the people of Texas unite as a community to support each other during challenging times like these.

## Human Trafficking

**Per Texas Occupations Code Sec. 156.060**, physicians must complete a course in human trafficking prevention approved by the Texas Health and Human Services Commission (HHSC). The course may be credited towards the requirements for medical ethics or professional responsibility for any physician. # Physician Fingerprinting Renewal Requirement



As part of recent legislation, physicians are required to submit fingerprints prior to having their license renewed unless they were fingerprinted for licensing after January 15, 2018. Please note that this is a one-time requirement; additional fingerprint results will not be required for subsequent renewals.

Licensees are encouraged to begin the process early. If you wish to submit your fingerprints before your renewal period, please e-mail **Registrations** and request instructions for your fingerprint submission, along with the required 6-digit ID number for submitting your fingerprints.

You can complete the fingerprint requirement at any point prior to your license expiration date.

Reminders of the fingerprint requirement will be included in the renewal notice sent out 90 days prior to the licensee's current expiration date. Detailed instructions will be included in the e-mail renewal reminder notices.

## **Continuing ED Tracking** with CE Broker

June marked the conclusion of the rollout of CE Broker. Now all TMB licensees have the option to establish a free, basic account with CE Broker. As a reminder, the Texas Medical Board partnered with CE Broker, an online continuing education compliance platform, to provide our licensees with an additional tool to help them more easily find, track, and report continuing education coursework.

## **ADOPTED RULES** Rule Changes Effective March 8, 2025

## **161. PHYSICIAN LICENSURE**

The adopted new section, §161.8, titled **Evaluation** of **Professional or Work History Requirements**, establishes requirements for professional or work history for physician licensure applicants. The section also describes how this professional or work history is evaluated by the board and how any deficiencies may be remediated by applicants. This section was erroneously excluded from the Board's proposed new rules published and adopted in 2024 during its rule review. This adoption remedies that error.




# **Case Review Experts Needed**

TMB is calling for physicians in several specialties to serve as experts in reviewing standard of care cases, specifically in the following areas: Medical Oncology, Neuropsychiatry, Pathology Laboratory Medicine, Pediatric Gastroenterology, Pediatric Neurology, Pediatric Pulmonology, Radiology (mammograms), and Transplant surgery (kidney and liver).

As an expert to the Board, your identity for any individual case will be confidential. **Reimbursement** for time spent performing case review is offered as is credit towards the continuing medical education requirements for Texas state licensure. The requirements for serving are:

- Active license to practice in Texas or a state that is a member of the Interstate Medical Licensure Compact
- Active practice
- No history of negative peer review action or license restriction
- Acceptable malpractice history
- Initial board certification by an organization that is a member of the American Board of Medical Specialties, the Bureau of Osteopathic Specialists or the American Board of Oral and Maxillofacial Surgery
