**TEXAS MEDICAL BOARD** 

LICENSURE COMMITTEE MEETING MINUTES

The meeting was called to order at 9:26 a.m. by Roberto D. Martinez, M.D., Chair. Other Committee

members present were Michael Cokinos, George De Loach, D.O., Luisa del Rosal, Tomeka Herod, Jayaram

B. Naidu, M.D. and Satish Nayak, M.D.

Committee members absent were Garry D. Crain and Kandace B. Farmer, D.O.

Agenda Item 2a. Proposed orders offered by the Executive Director.

Ms. Unterborn reported on 1 Remedial Plan offered by the Executive Director and accepted by the applicant.

After discussion Dr. Nayak moved to recommend to the full Board that the 1 Agreed Order be approved.

Ms. Herod seconded the motion. All voted in favor and the motion passed.

Agenda Item 2b. Physician licensure applicants to be licensed.

Ms. Unterborn reported that there were 200 Physician Licensure applicants who met all the requirements to be

considered for permanent licensure by the full Board. Ms. del Rosal moved to recommend to the full Board

that all 200 Physician Licensure applicants that have been determined to meet eligibility requirements by

staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Agenda Item 2c. Surgical Assistant licensure applicants to be licensed.

Ms. Unterborn reported that there were 5 Surgical Assistant applicants who met all the requirements to be

considered for licensure by the full Board. Ms. Herod moved to recommend to the full Board that the 5

Surgical Assistant applicants that have been determined to meet eligibility requirements by staff be

approved. Dr. Nayak seconded the motion. All voted in favor and the motion passed.

Agenda Item 2d. Acudetox applicants to be certified.

Ms. Unterborn reported that there were 2 Acudetox applicants who met all the requirements to be considered for

licensure by the full Board. Dr. Nayak moved to recommend to the full Board that the 2 Acudetox applicants

that have been determined to meet eligibility requirements by staff be approved. Dr. De Loach seconded

the motion. All voted in favor and the motion passed.

Ms. Unterborn reported that in Quarter 1 of FY24, 1228 new physician licenses were issued in an average processing time of 28 days. In Quarter 1 of FY25, 1023 new physician licenses were issued in an average processing time of 24 days.

#### Compact statistics:

Ms. Unterborn reported that in Quarter 1 of FY 24, 424 new Compact physician licenses were issued in an average processing time of 10 days. In Quarter 1 of FY 25, 447 new Compact physician licenses were issued in an average processing time of 10 days.

#### Agenda Item 5a. Nonprofit Health Organizations - Applicants for Initial Certification.

Ms. Unterborn reported there were 8 applicants for initial certification as a Nonprofit Health Organization for approval. Dr. Nayak moved to recommend to the full Board that the 8 applicants that have been determined by staff to meet eligibility requirements for initial certification as a Nonprofit Health Organization be approved. Ms. Herod seconded the motion. All voted in favor and the motion passed.

#### Agenda Item 5b. Nonprofit Health Organizations - Requests for Biennial Recertification.

Ms. Unterborn reported there were 120 requests for biennial recertification as a Nonprofit Health Organization for approval. Ms. Herod moved to recommend to the full Board that the 120 requests that have been determined by staff to meet eligibility requirements for biennial recertification as a Nonprofit Health Organization be approved. Dr. Nayak seconded the motion. All voted in favor and the motion passed.

Agenda Item 5c. Nonprofit Health Organizations – Cancellation of organizations certified as Nonprofit Health Organizations.

Ms. Unterborn reported there was 1 organization for cancellation as a Nonprofit Health Organization for approval. Mr. Cokinos moved to recommend to the full Board that the 1 organization for cancellation as a Nonprofit Health Organization be approved. Ms. Herod seconded the motion. All voted in favor and the motion passed.

There are none.


#### Agenda Item 11. Adjourn.
