TEXAS MEDICAL BOARD

LICENSURE COMMITTEE MEETING MINUTES

December 6, 2018

The meeting was called to order 10:17 a.m. by Chair, Timothy Webb, J.D. Other Committee members present were Michael Cokinos, Frank S. Denton, Kandace Farmer, D.O., Jeffrey L. Luna, M.D., Roberto Martinez, M.D., Linda Molina, J.D., and Karl Swann, M.D. Committee members absent were George De Loach, D.O. and Jayaram B. Naidu, M.D.

Mr. Cokinos moved, and Dr. Farmer seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Item 3a. The motion passed. Mr. Webb announced that the meeting would be closed for deliberations at 10:19 a.m. concerning licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

Dr Luna left the meeting at 12:00 p.m.

The Executive Session ended at 1:39 p.m. The Licensure Committee conducted hearings to review licensees appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

Agenda Item 3a - Applicants appearing concerning eligibility.

Applicant #2263 appeared before the Committee, with counsel, in executive session. In open session, Dr. Farmer moved that the committee recommend to the full Board that the Applicant be granted an unrestricted license. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Applicant #2251 appeared before the Committee in executive session. In open session, Mr. Cokinos moved that the committee recommend to the full Board that the applicant be granted an unrestricted license. Dr. Farmer seconded the motion. All voted in favor and the motion passed.

Applicant #1556 appeared before the Committee, with counsel, in executive session. In open session, Dr. Martinez moved that the committee recommend to the full Board that the Applicant be determined ineligible for a physician in training permit due to the Applicant's unprofessional conduct; excessive use of drugs, narcotics, chemicals or another substance that makes the Applicant unable to practice medicine with reasonable skill and safety to patients; and intemperate use of alcohol or drugs that could endanger the public. Mr. Cokinos seconded the motion. All voted in favor. The motion passed.

Applicant #2261 appeared before the Committee in executive session. In open session, Mr. Cokinos moved that the committee recommend to the full Board that the Applicant be granted an unrestricted license. Dr. Swann seconded the motion. Dr. Martinez, Dr. Swann, Dr. Farmer and Ms. Molina voted in favor of the motion. Mr. Denton voted against the motion. The motion passed.

Applicant #2264 appeared before the Committee in executive session. In open session, Mr. Denton moved that the committee recommend to the full Board that the Applicant's appeal be granted, the Executive Director's offer of the remedial plan be withdrawn, and the Applicant be granted an unrestricted license. Dr. Martinez seconded the motion. All voted in favor. The motion passed.

Applicant #2267 appeared before the Committee in executive session. In open session, Ms. Molina moved that the committee recommend to the full Board that the Applicant's request for reinstatement of their license be denied due to unprofessional conduct; excessive use of drugs, narcotics, chemicals, or another substance that makes the applicant unable to practice medicine with reasonable skill and safety to patients; intemperate use of

alcohol or drugs that could endanger the public; and time out of practice. Mr. Cokinos seconded the motion. All voted in favor. The motion passed.

Applicant #2265 appeared before the Committee, with counsel, in executive session. In open session, Mr. Cokinos moved that the committee recommend to the full Board that the Applicant's appeal of the Executive Director's determination of ineligibility for reinstatement of their license be denied due to the Applicant's failure to meet the requirements of Sections 155.003(a)(2) and 164.151(c) of the Texas Occupations Code. Dr. Farmer seconded the motion. All voted in favor. The motion passed.

Agenda Item 3b – Proposed orders offered by the Executive Director.

Ms. Johnston reported on 2 Remedial Plans offered by the Executive Director and accepted by the applicants. Dr. Farmer moved to recommend to the full Board that the 2 Remedial Plans be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Agenda Item 3c – Physician licensure applicants to be licensed.

Ms. Johnston reported that there were 202 applicants who met all requirements to be considered for permanent licensure by the full Board. Mr. Denton moved to recommend to the full Board that all 202 physician licensure applicants determined to meet eligibility requirements by staff be approved. Dr. Farmer seconded the motion. All voted in favor and the motion passed.

Agenda Item 3d – Surgical assistant licensure applicants to be licensed.

Ms. Johnston reported that were 11 surgical assistant applicants who met all requirements to be considered for licensure by the full Board. Dr. Farmer moved to recommend to the full Board that all 11 surgical assistant applicants determined to meet eligibility requirements by staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.

Agenda Item 3e – Acudetox Specialist applicants to be certified.

Ms. Johnston reported that was 1 Acudetox specialist applicant who met all requirements to be considered for licensure by the full Board. Mr. Cokinos moved to recommend to the full

Board that the 1 Acudetox specialist applicant determined to meet eligibility requirements by staff be approved. Dr. Farmer seconded the motion. All voted in favor and the motion passed.

Agenda Item 4 – Report on licensure statistics.

Ms. Johnston reported that in Quarter 1 of FY18, 872 new physician licenses were issued in an average processing time of 45 days. In Quarter 1 of FY19, 907 licenses were issued in an average processing time of 39 days.

Agenda Item 5a – Cancellation of Licenses by request or for incomplete registration – Surgical Assistants. There are none.

Agenda Item 5b – Cancellation of Licenses by request or for incomplete registration – **Acudetox.** There are none.

Agenda Item 6a -Nonprofit Health Organizations - Applicants for Initial Certification.

Ms. Johnston reported that were 4 applicants for initial certification as a Nonprofit Health Organization for approval. Mr. Cokinos moved to recommend to the full Board that the 4 requests for initial certification as a Nonprofit Health Organization be approved. Dr. Farmer seconded the motion. All voted in favor and the motion passed.

Agenda Item 6b - Nonprofit Health Organizations - Requests for Biennial Recertification. Ms. Johnston reported that were 2 requests for biennial certification as a Nonprofit Health Organization for approval. Ms. Molina moved to recommend to the full Board that the 2 requests for biennial certification as a Nonprofit Health Organization be approved. Dr. Martinez seconded. All voted in favor and the motion passed.

Agenda Item 6c - Nonprofit Health Organizations – Cancellation of Certification.There are none.

Agenda Item 7 – Proposed amendments to Title 22 of the Texas Administrative Code.

There are none.


Agenda Item 8 – Adjourn.
