



TEXAS STATE BOARD OF ACUPUNCTURE EXAMINERS

LICENSURE COMMITTEE MEETING MINUTES

October 5, 2018

The meeting was called to order at 9:24 a.m. by the Chair, Allen Cline, L.Ac. Other committee members present were Rachelle Webb, L.Ac. and Jeremy Wiseman, M.D.

Agenda Item 2 – Discussion, recommendation, and possible action regarding applicants appearing concerning eligibility.

Applicant #2226 appeared before the Committee to appeal the Executive Director's determination of ineligibility due to the applicant's inability to present proof that they have taken and passed within five attempts each component of the full National Certification Commission for Acupuncture and Oriental Medicine (NCCACOM) examination, specifically the Biomedicine module, as required under Board rule §183.4(a)(5). The applicant presented a brief summary and the Committee members asked questions. **Ms. Webb moved that the committee recommend to the full Board that the applicant's appeal be denied and the original determination stands. Dr. Wiseman seconded the motion. All voted in favor. The motion passed.**

Agenda Item 3 – Discussion, recommendation, and possible action regarding applicants for a Texas Acupuncture License.

Ms. Johnston reported that there were 38 applicants who met all requirements to be considered for permanent licensure by the full Board. Ms. Webb moved to recommend to the full board that the 38 acupuncture licensure applicants determined to meet eligibility requirements by staff be approved. Dr. Wiseman seconded the motion. All voted in favor and the motion passed.
