

**TEXAS MEDICAL BOARD**  
**MINUTES OF THE**  
**DISCIPLINARY PROCESS REVIEW COMMITTEE**  
August 25, 2011

Chair Melinda McMichael, M.D., called the meeting to order at 11:12a.m. Other members present were Julie K. Attebury, David Baucom, Patricia S. Blackwell, Manuel Guajardo, M.D., James Scott Holliday, D.O., Allan Shulkin, M.D., Stanley S. Wang, M.D., George Willeford III, M.D., and Irvin E. Zeitler, Jr., D.O. Committee Member Margaret C. McNeese, M.D. was not present.

Also present was Mari Robinson, Executive Director, and various other staff.

**Agenda Item #2.** Discussion, recommendation, and possible action regarding referrals and reports from the Texas Physician Health Program.

The Executive Director, Dr. Bill Nemeth discussed nine cases that the Texas Physician Health Program is currently working and requested additional guidance on.

**Dr. Wang moved, and Ms. Blackwell seconded that TX PHP cases #11-0253, 10-0143, 10-0147, 10-0342, and 11-0139, be returned to the jurisdiction of the Texas Medical Board and the Respondents be scheduled for an ISC. Motion carried.**

**Dr. Willeford moved, and Ms. Blackwell seconded that TX PHP cases #11-0188, 10-0363, and 11-0215 remain under the management of the Texas Physician Health Program. Motion carried.**

**Dr. Willeford moved, and Dr. Wang seconded that TX PHP case #11-0189 be returned to the jurisdiction of the Texas Medical Board and the Respondent be scheduled for an ISC. Motion carried.**

**Dr. Zeitler moved, and Ms. Blackwell seconded; the motion passed at 11:47a.m. to go into Executive Session deliberations concerning disciplinary action, investigative information, peer review information, and rehabilitation orders under the authority of The Medical Practice Act Sections 152.009, 160.006 through .008, 164.007(c), and 164.202 & .203, Occupations Code.** Open session resumed at 12:30p.m. and it was announced that no action was taken during executive session. A certified agenda of the executive session was made.

To date, there are approximately 482 investigations that fall under this category; the majority being SOAH cases and cases pending expert panel review. This was an informational item only and no vote was necessary.

**Dr. Zeitler moved, and Ms. Blackwell seconded; the motion passed at 4:55p.m. to go into Executive Session deliberations concerning disciplinary action, investigative information, peer review information, and rehabilitation orders under the authority of The Medical Practice Act Sections 152.009, 160.006 through .008, 164.007(c), and 164.202 & .203, Occupations Code.** Open session resumed at 5:11p.m. and it was announced that no action was taken during executive session. A certified agenda of the executive session was made.

It was directed that there should be no further mediation on this matter. Motion carried.**

**Dr. Zeitler moved, and Ms. Blackwell seconded that Log #09-3345 be denied with a letter to the Respondent emphasizing the need to improve written and electronic medical records. Motion carried.**

**Dr. Zeitler moved, and Ms. Blackwell seconded that the remaining routine follow-up files be dismissed. Motion carried.**

**Agenda Item #10.** Review, discussion, and possible action regarding selected files and cases.  
**Dr. Wang recused himself from any discussion and decision regarding Log #11-5979.**

**Dr. Shulkin moved, and Mr. Baucom seconded that the investigations and cases reviewed by the committee be resolved as noted and that they be listed along with each resolution as part of the minutes of this Committee. Motion carried.**
