



**TEXAS PHYSICIAN ASSISTANT BOARD  
LICENSURE COMMITTEE MEETING MINUTES**

March 8, 2013

The meeting was called to order at 9:43 a.m. by the Chair, Teralea Jones, PA-C. Committee members present were Richard Rahr, Ed.D, PA-C and Michael D. Reis, M.D.

**Agenda Item 2 – Discussion, recommendation, and possible action regarding licensure applicants referred to the Licensure Committee by the Executive Director for determination of eligibility of licensure.**

**Applicant #1336** appeared before the Committee after deferral by the December 14, 2012 Licensure Committee to allow the applicant to undergo fingerprinting through the FBI. Following discussion, **Dr. Rahr moved to recommend to the full Board that the applicant be granted a Texas Physician Assistant license. Dr. Reis seconded the motion. All voted in favor. The motion passed.**

**Applicant #1361** appeared before the Committee, with counsel, after referral by the Executive Director. Following discussion, **Dr. Rahr moved to recommend to the full Board that the applicant be granted a Texas Physician Assistant license. Dr. Reis seconded the motion. All voted in favor. The motion passed.**

**Applicant #1359** appeared before the Committee after referral by the Executive Director. Following discussion, **Dr. Rahr moved to recommend to the full Board that the applicant be granted a Texas physician assistant temporary license with an expiration date that will allow the applicant to obtain at least 20 hours a week supervised practice for at least 40 weeks in a 12-month period, subject to the following restrictions: that the applicant work full time, only in a setting that provides continuous full-time, on-site physician supervision; the applicant be restricted from prescribing controlled substances; the supervising physician shall submit, quarterly reports regarding the applicant's work performance; the**

supervising physician shall submit, one month prior to the temporary license expiring, a log showing time worked regarding the applicant's work performance; if the evaluations are favorable, the applicant's name may be placed on a list of applicants who have met all requirements for licensure to be considered at the following board meeting; if the evaluation is unsatisfactory, the applicant will be required to appear at the following Board meeting for reconsideration of the application. This recommendation is due to the applicant not practicing since graduation from the applicant's PA program in 2010, not passing the NCCPA certification exam until October of 2012 on his fifth attempt, and being placed on academic probation by the PA program from 2007 to 2010. **Dr. Reis seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 3- Discussion, recommendation, and possible action regarding review of Physician Assistant applications for permanent licensure.** There were 201 applicants and 7 re-licensure applicants who met all requirements to be considered for permanent licensure by the full Board. **Dr. Rahr moved to recommend to the full board that all 201 applicants and 7 relicensure applicants be approved for permanent licensure. Dr. Reis seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 4 - Report on physician assistant licensure process statistics** – Ms. Knight reported that the 182 new PA licenses issued in the second quarter of fiscal year 2013 were completed in an average of 29 days.

**Agenda Item 5 – Reapplication by applicants previously determined ineligible** – Ms. Knight discussed an applicant who was determined ineligible by the Licensure Committee on March 9, 2012 and reapplied shortly thereafter in September 2012. The committee discussed whether they felt there should be a certain length of time an applicant should have to wait to reapply after being determined ineligible.

**Dr. Rhar moved to recommend to the full board that applicants who have been determined ineligible by the committee, if the reasons for that determination have not changed, must wait one year to reapply for licensure. Dr. Reis seconded the motion. All voted in favor and the motion passed.**

**Dr. Rharr moved, Dr. Reis seconded, that the Committee close the meeting to the public and continue in Executive Session to seek legal advice concerning Agenda item 5. The motion passed.** Ms. Jones announced that the meeting would be closed for deliberations at 10:37 a.m. concerning private consultation and advice of counsel concerning pending or contemplated litigation, settlement offers, and/or legal matters subject to the attorney-client privilege under the authority of the Open Meetings Act Section 551.071, Government Code. While in executive session, the Board will not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

The Executive Session ended at 10:46 a.m.

**Agenda Item 5 Continued –**

**Dr. Rharr moved to recommend to the full board that from this day forward applicants who have been determined ineligible by the committee must wait one year to reapply for licensure if the reasons for that determination of ineligibility have not changed. Dr. Reis seconded the motion. All voted in favor and the motion passed.**

**Agenda Item 6-** There being no further business, the meeting adjourned at 10:48 a.m.
