BOARD MEETING MINUTES

SEPTEMBER 27, 2019

The meeting was called to order at 9:49 a.m. by Allen D. Cline, L.Ac., Presiding Officer. Board members Raymond J. Graham, Donna S. Guthery, L.Ac., Assistant Presiding Officer, Mary E. Hebert, M.D., and Grant E. Weidler, MAOM, L.Ac. were present. Jingyu Gu, L.Ac., Claudine K. Vass, Rachelle L. Webb, L.Ac., and Jeremy Wiseman, M.D., did not attend. Staff members present were Stephen 'Brint' Carlton, J.D., Executive Director; Scott Freshour, General Counsel, Wendy Pajak, Assistant General Counsel; Robert Bredt, M.D., Medical Director; and the Assistant General Counsels, Sarah Tuthill, J.D., and Amy Swanholm, J.D.; and various other staff.

Agenda Item #2, Board Member Report. Mr. Cline reported that the NCCAOM now accepts CA state board testing to obtain diplomat status. After discussion, board directed staff to review our current board rules to determine whether NCCAOM's action will affect Texas licensure requirements.
