LICENSURE COMMITTEE MEETING MINUTES
VIDEO CONFERENCE MEETING
JUNE 8, 2023

The meeting was called to order 9:36 a.m. by Roberto D. Martinez, M.D., Chair. Other Committee members present were Michael Cokinos, George De Loach, D.O., Kandace B. Farmer, D.O., Satish Nayak, M.D and Ebony Todd, J.D.

Committee members absent were Jayaram B. Naidu, M.D. and Tomeka M. Herod.

Jayaram B. Naidu, M.D. entered the meeting at 9:38 a.m.

Ms. Todd left the meeting at 10:17 a.m.

Mr. Cokinos left the meeting at 1:30 p.m.

Ms. Todd returned to the meeting at 1:34 p.m.

Agenda Item 2a. Proposed orders offered by the Executive Director.

Ms. Unterborn reported on **1** Remedial Plan offered by the Executive Director and accepted by the applicant. After discussion **Ms. Todd moved to recommend to the full Board that the 1 Remedial Plan be approved. Dr. De Loach seconded the motion. All voted in favor and the motion passed.**

Agenda Item 2b. Physician licensure applicants to be licensed.

Ms. Unterborn reported that there were **309** applicants who met all the requirements to be considered for permanent licensure by the full Board. **Dr. Nayak moved to recommend to the full Board that all 309 physician licensure applicants determined to meet eligibility requirements by staff be approved. Ms. Todd seconded the motion. All voted in favor and the motion passed.**

Agenda Item 2c. Surgical Assistant licensure applicants to be licensed.

Ms. Unterborn reported that were **16** surgical assistant applicants who met all the requirements to be considered for licensure by the full Board. **Dr. Nayak moved to recommend to the full Board that the 1 Surgical Assistant applicant determined to meet eligibility requirements by staff be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.**

Agenda Item 2d. Acudetox applicants to be certified.

Ms. Unterborn reported that was **1** Acudetox applicant who met all the requirements to be considered for licensure by the full Board. **Ms. Todd moved to recommend to the full Board that the 16 surgical assistant applicants**

determined to meet eligibility requirements by staff be approved. Dr. Naidu seconded the motion. All voted in favor and the motion passed.

Agenda Item 3. Report on Physician licensure statistics.

Non-Compact statistics:

Ms. Unterborn reported that in Quarter 3 of FY 22, 1983 new physician licenses were issued in an average processing time of 19 days. In Quarter 3 of FY 23, 1895 new physician licenses were issued in an average processing time of 19 days.

Compact statistics:

Ms. Unterborn reported that in Quarter 3 of FY 22, 373 new Compact physician licenses were issued in an average processing time of 12 days. Ms. Unterborn reported that in Quarter 4 of FY 23, 474 new Compact licenses were issued in an average processing time of 11 days.

Agenda Item 4a. Cancellation of licenses by request or for incomplete registration – Surgical Assistants.

There are none.

Agenda Item 4b. Cancellation of licenses by request or for incomplete registration – Acudetox.

Ms. Unterborn reported there were **12** Acudetox licenses for cancellation by request or for incomplete registration for approval. **Dr. Nayak moved to recommend to the full Board that the 12 licenses for cancellation be approved. Ms. Todd seconded the motion. All voted in favor and the motion passed.**

Agenda Item 5a. Nonprofit Health Organizations - Applicants for Initial Certification.

Ms. Unterborn reported there were **6** applicants for initial certification as a Nonprofit Health Organization for approval. **Ms. Todd moved to recommend to the full Board that the 6 applicants for initial certification as a Nonprofit Health Organization be approved. Mr. Cokinos seconded the motion. All voted in favor and the motion passed.**

Agenda Item 5b. Nonprofit Health Organizations - Requests for Biennial Recertification.

Ms. Unterborn reported there were **8** requests for biennial recertification as a Nonprofit Health Organization for approval. **Ms. Todd moved to recommend to the full Board that the 8 requests for biennial recertification as a Nonprofit Health Organization be approved. Dr. Nayak seconded the motion. All voted in favor and the motion passed.**

Agenda Item 5c. Nonprofit Health Organizations – Cancellation of organizations certified as Nonprofit Health Organizations.

There are none.

Agenda Item 6. Report on renewal for Advertising Board Certification.

Ms. Unterborn reported there was **1** renewal of a certifying board that is recognized for the purposes of Advertisement Only.

Agenda Item 7. Discussion, recommendation and possible action regarding proposed amendments to Title 22 of the Texas Administrative Code.

There are none.

Ms. Todd moved, and Dr. De Loach, seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Agenda Items 8 and 9. The motion passed. Dr. Martinez announced that the meeting would be closed for deliberations at 9:43 a.m. concerning licensees and licensure applications and the character and fitness of applicants under the authority of The Medical Practice Act Sections 152.009 and 155.058, Occupations Code, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made.

The Executive Session ended at 1:34 p.m. The Licensure Committee conducted hearings to review licensure applicants appearing concerning eligibility. The hearings were conducted in Executive Session. Following the hearings, the Committee reconvened and considered the applications.

Agenda Item 8. Licensee requests.

Applicant #1168 appeared before the Committee in executive session. In open session, **Dr. Naidu moved that the committee recommend to the full Board that the licensee's request to return to active status be deferred pending completion of the following conditions:**

- **Within 6 months, completion of an evaluation by KSTAR. If the final report is favorable and no areas of deficiency are identified, the Executive Director can approve the licensee's request return to active status.**
- **If the KSTAR evaluation identifies any areas of deficiency, the licensee must reappear before the Licensure Committee to address deficiencies identified by KSTAR.**

This recommendation is due to the licensee's time out of active practice. Dr. Nayak seconded the motion. All voted in favor and the motion passed.

Applicant #2570 appeared before the Committee in executive session. In open session, **Dr. Farmer** moved that the committee recommend to the full Board that the Licensee's request for reactivation from retired status be denied due to the licensee's conviction of a felony. **Dr. Naidu** seconded the motion. All voted in favor and the motion passed.

Agenda Item 9. Applicants appearing concerning eligibility.

Applicant #2567 appeared before the Committee, with counsel, in executive session. In open session, **Dr. Naidu** moved that the committee recommend to the full Board that a determination be deferred, pending completion of the following conditions:

- **Completion of an Independent Medical Evaluation (IME) by a board-certified psychiatrist that has been approved by the Executive Director of the Board related to issues that arose during a postgraduate training program.**
- **The applicant will be required to reappear before the Committee after completion of the evaluation to consider the findings of the IME.**
- **The evaluation must be completed before their application expires in September 2023. If the evaluation is not completed before the application expires, their application will expire and be considered withdrawn.**

This recommendation is due to the issues the Applicant had during their postgraduate training program. Dr. De Loach seconded the motion. All voted in favor and the motion passed.

Applicant #2571 appeared before the Committee in executive session. In open session, **Dr. De Loach** moved that the committee recommend to the full Board that the Applicant be determined ineligible for a license due to multiple issues arising during various residency programs and criminal history. **Dr. Naidu** seconded the motion. All voted in favor and the motion passed.

Applicant #2572 appeared before the Committee, with counsel, in executive session. In open session, **Dr. Nayak** moved that the committee recommend to the full Board that the Applicant's application for reinstatement of their license be deferred pending completion of the following conditions:

- **Completion of an evaluation by KSTAR.**
- **The applicant will be required to reappear before the Committee after completion of the evaluation to consider the findings of the evaluation.**

- **The evaluation must be completed before their application expires in January 2024. If the evaluation is not completed before the application expires, their application will expire and be considered withdrawn.**

This recommendation is due to the Applicant's time out of active practice. Dr. Farmer seconded the motion. All voted in favor and the motion passed.

Applicant #2370 appeared before the Committee in executive session. In open session, **Dr. Nayak moved that the committee recommend to the full Board that the Applicant's application for reinstatement of their license be subject to an Agreed Order due to the Applicant's time out of active practice of medicine.**

- **Practice for 3 months under the supervision of a licensed Texas physician that has been approved in advance by the Executive Director of the Board.**
- **The supervising physician must submit a report at the end of the 3-month period and if the report is favorable, the Agreed Order will auto terminate.**
- **If the report is not favorable, the Applicant must make a required appearance before an Informal Settlement Conference (ISC) Panel for further consideration.**

Dr. Naidu seconded the motion. All voted in favor and the motion passed.

10. Applicants for Advertising Board Certification.

There are none.

11. Adjourn.

There being no further business, **Dr. Farmer moved to adjourn the meeting. Dr. Nayak seconded the motion. All voted in favor and the motion passed. The meeting was adjourned at 1:43 p.m.**
