- 5. [AA / NA] AA OR NA meeting at least \_\_3\_ times each week OR month. [e16 or e17] 1 of 3 meeting can be in Caduceus

## **PSYCHIATRIC:**

- 8. [**PSYCHIATRIC TREATMENT No IPE**] Submit up to 3 names for treating psychiatrist for approval of ED; see at least <u>1</u> times each week OR month. Treating psychiatrist to report to Board or monitoring psychiatrist 4 times each year. [e05]
- 9. [MONITOR FOR TREATMENT Required with either 7 or 8] Treating psychiatrist may agree to be monitoring psychiatrist or ED appoints a monitoring psychiatrist; monitoring psychiatrist to report to Board 2 times each year. [e06]

23. [ABILITY TO SUPERVISE] May May NOT supervise PAs and APNs [002] NOTE: If Order includes restrictions on license; PA Act prohibits supervision.
