### **Texas Medical Board Expediting Temporary Licenses for Out of State Physicians**

The Texas Medical Board has created an expedited process for physicians coming into Texas from Louisiana and other areas devastated by Hurricane Katrina, as well as physicians coming from other states wishing to assist with the relief effort.

The agency is using its ability to issue temporary permits, which require a licensed Texas physician to sponsor the incoming visiting physician, and extending the normal 10-day expiration to 45 days, during which time the agency will re-evaluate those physicians wishing to stay in Texas for a longer period. There is no fee for the temporary permit.

The agency posted information on its web site Thursday, and began processing permits Friday. Licensure staff worked over the holiday weekend to accept and process permits and by Tuesday morning 28 had been issued, some to Louisiana doctors wanting to volunteer or needing to work and others from California, the District of Columbia, Kentucky, New Jersey and Wisconsin.

There were sporadic e-mail problems during the weekend due to required network maintenance resulting from the agency's name change to Texas Medical Board on September 1, but they are now resolved.
