LICENSURE COMMITTEE MEETING MINUTES

November 4, 2016

The meeting was called to order at 9:00 a.m. by Chair, Teralea Jones, PA-C. Committee members present were Karrie L. Crosby, PA-C, Victor Shen-Pou Ho, M.D., and Jason P. Cooper, PA-C.

Agenda Item 2 – Applicants appearing concerning eligibility.

Applicant #1926 appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Ms. Crosby moved to recommend to the full Board that the applicant be granted a Texas physician assistant license. Mr. Cooper seconded the motion. All voted in favor. The motion passed.**

Interim Executive Director, Scott Freshour, then discussed the unintended consequences of referring applicants for licensure who have a felony record due to an arrest that occurred while they were a juvenile and had no further criminal actions. **Ms. Jones** suggested that applicants with a juvenile felony record be referred to the Chair of the Licensure Committee and in conjunction with the Executive Director, or Interim Executive Director, to determine if the applicant should be referred to the Licensure Committee for a determination of licensure.

Applicant #1856 appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Ms. Crosby moved to recommend to the full Board that the applicant be granted a Texas physician assistant supervised temporary license with an expiration date that will allow the applicant to obtain at least 20 hours a week supervised practice for**

at least 40 weeks in a 12-month period subject to the following restrictions: that the applicant work full time, only in an academic or group practice setting that provides continuous full-time, on-site physician supervision; the applicant be restricted from prescribing controlled substances; the supervising physician shall submit, quarterly reports regarding the applicant's work performance; the supervising physician shall submit, one month prior to the temporary license expiring, a log showing time worked regarding the applicant's work performance. The applicant will be required to reappear before the Licensure Committee at the end of 12-month period for a determination of licensure. If the applicant's supervised temporary license expires prior to the applicant's appearance before the Committee, board staff is directed to extend the supervised temporary license to accommodate the applicant. Factors contributing to this recommendation include action taken against the applicant by the Texas Physician Assistant Board and the applicant's time out of practice as a physician assistant. **Mr. Cooper seconded the motion. All voted in favor. The motion passed.**

Applicant #1892 appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Mr. Cooper moved to recommend to the full Board that the applicant be granted a Texas physician assistant license. Ms. Crosby per seconded the motion. All voted in favor. The motion passed.**

Applicant #1899 appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Ms. Crosby moved to recommend to the full Board that the applicant be granted a Texas physician assistant license. Mr. Cooper seconded the motion. All voted in favor. The motion passed.**

Agenda Item 3 - Discussion, recommendation, and possible action regarding review of Physician Assistant applications for permanent licensure - Ms. Johnston reported there were 210 regular applicants and 5 relicensure applicants who met all requirements to be considered for permanent licensure by the full Board. **Ms. Crosby moved to recommend to the full board**

that all 210 regular applicants and 5 relicensure applicants be approved for permanent licensure. Mr. Cooper seconded the motion. All voted in favor and the motion passed.

Agenda Item 4 – Proposed Orders Offered by the Executive Director – Ms. Johnston reported on 1 physician assistant agreed order offered by the Executive Director and accepted by the applicant. **Mr. Cooper moved to recommend to the full Board that the agreed order be approved. Ms. Crosby seconded. All voted in favor. The motion passed.**

Agenda Item 5 - Report on physician assistant licensure process statistics – Ms. Johnston reported that 676 physician assistant licenses were issued in the Fiscal Year 2016 in an average of 23 days. In Fiscal Year 2016, 891 physician assistant licenses were issued in an average of 26 days. Additionally, 2,513 SB 202 new license types were issued between 12/1/15 and 8/31/16.

Agenda Item 6 - Discussion, recommendation, and possible action regarding obtaining a DEA number with a temporary license. Per the DEA a physician assistant must register their supervising physician prior to applying for a DEA Controlled Substance Registration under a temporary license. If the physician assistant is still not able to register for the DEA, they should contact board staff for assistance.

Agenda Item 7 - There being no further business, Ms. Crosby moved to adjourn the meeting at 10:10 a.m. Mr. Cooper seconded the motion. All voted in favor and the motion passed.
