## TMB disciplines 22 physicians at June meeting

At its June 13, 2025, meeting, the Texas Medical Board disciplined 22 licensed physicians.

The disciplinary actions included: one order related to violation of Board rules, one related to impairment, one order related to nontherapeutic prescribing, seven orders related to peer review or other states' actions, two orders related to standard of care, two orders related to unprofessional conduct, one voluntary surrender, two Consent Orders, and five Mediated Settlement Agreed Orders. The Board also ratified three cease-and-desist orders.
