MINUTES OF THE DISCIPLINARY PROCESS REVIEW COMMITTEE

Manuel Quinones, Jr., M.D., Committee Chair, called the meeting to order at 9:58 a.m. Other members present were Sharon Barnes, Devinder S. Bhatia, M.D., Robert Gracia, LuAnn Morgan, Jason K. Tibbles, M.D., David Vanderweide, M.D., and Sherif Zaafran, M.D. James S. Distefano, D.O. did not attend.

Staff members present were Stephen Brint Carlton, J.D., Executive Director; Robert Bredt, M.D., Medical Director; Chris Palazola, J.D., Director of Operations; and various other staff.

Agenda Item #2. Texas Physician Health Program (TXPHP).

A. Discussion, recommendation, and possible action regarding referrals.

Ms. Barnes moved and Dr. Vanderweide seconded that TXPHP Case Nos. 15-0152 MD and 20-1102-A MD be returned to the jurisdiction of the TMB. Motion carried

Dr. Bhatia moved and Ms. Barnes seconded that TXPHP Case Nos. 14-0340-A MD, 17-0209-A MD, 18-0168-A MD, 18-0397 MD, 21-0508 MD, 21-1108 MD, and 22-0306 PIT MD, remain under the management of TXPHP. Motion carried.

Dr. Bhatia moved and Ms. Barnes seconded that TXPHP Case No. 23-0904 PIT MD be returned to the jurisdiction of TMB. Motion carried.

Dr. Quinones moved and Ms. Morgan seconded to deny the approval of dismissal for case 23-0618 and offer an agreed order that requires the respondent to within 72 hours of the order's entry by the Board, complete an application for registration of his pain management clinic or cease operations as a pain management clinic, restricts the respondent from treating chronic pain outside of the setting of a pain management clinic registered with the Board, imposes a \$10,000 fine to be paid by the respondent within 60 days of the order's entry by the Board, and requires the respondent to pass the JP Exam within 1 year of the order's entry by the Board. If information is obtained that indicates the respondent submitted a completed and approved application for registration as a pain management clinic with the Board as of the date of the 3/21/24 meeting, the case shall be returned to the committee, for consideration of possible dismissal or other appropriate action. The motion carried.

Dr. Quinones moved and Dr. Zaafran seconded to deny the approval of dismissal of case 24-3416 and send back to investigations. The motion carried.

Dr. Quinones moved and Ms. Barnes seconded to deny the approval of dismissal of case 23-5111 and to refer to ISC for further action. The motion carried.

Dr. Bhatia moved and Dr. Zaafran seconded to deny the approval of dismissal for case 23-5773 and send to ISC. The motion carried.

Dr. Vanderweide moved and Dr. Tibbels seconded that the meeting adjourn.
