

## **TEXAS PHYSICIAN ASSISTANT BOARD** LICENSURE COMMITTEE MEETING MINUTES

December 5, 2014

The meeting was called to order at 9:00 a.m. by the Chair, Teralea Jones, PA-C. Committee members present were Jason P. Cooper, PA-C, Michael D. Reis, M.D., and Blayne Rush.

Agenda Item 2 – Discussion, recommendation, and possible action regarding licensure applicants referred to the Licensure Committee by the Executive Director for determination of eligibility of licensure.

**Applicant #1113** appeared before the Committee after referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions.

Dr. Reis moved, and Mr. Cooper seconded, that the Committee close the meeting to the public for the purpose of private consultation and advice of counsel. The motion passed. Ms. Jones announced this meeting is now closed to the public at 9:20 a.m. on December 5, 2014. The meeting will continue in executive session for the purpose of private consultation and advice of counsel concerning pending or contemplated litigation, settlement offers, and/or legal matters subject to the attorney-client privilege under the authority of the Open Meetings Act Section 551.071, Government Code. While in executive session, the Board will not take any action, make any decision, or vote with regard to any matter that may be considered or discussed.

The Executive Session ended at 9:27

The Committee had more questions for Applicant #1113 Following discussion, Mr. Cooper moved to recommend to the full Board that the applicant be granted a Texas physician assistant license. Dr. Reis seconded the motion. Mr. Rush voted against the motion. All others voted in favor. The motion passed.

**Applicant #1612** appeared before the Committee after referral by the Executive Director. Following discussion, **Mr. Cooper moved to recommend to the full Board that the applicant be granted a Texas physician assistant license. Mr. Rush seconded the motion. All voted in favor. The motion passed**.

**Applicant #1406** appeared before the Committee, with counsel, after referral by the Executive Director. The applicant's counsel presented a statement, as did the applicant. The Committee asked questions.

Mr. Rush moved, and Dr. Reis seconded, that the Committee close the meeting to the public for the purpose of private consultation and advice of counsel. The motion passed. Ms. Jones announced this meeting is now closed to the public at 10:03 a.m. on December 5, 2014. The meeting will continue in executive session for the purpose of private consultation and advice of counsel concerning pending or contemplated litigation, settlement offers, and/or legal matters subject to the attorney-client privilege under the authority of the Open Meetings Act Section 551.071, Government Code. While in executive session, the Board will not take any action, make any decision, or vote with regard to any matter that may be considered or discussed.

#### The Executive Session ended at 10:10 a.m.

The Committee had more questions for Applicant #1406. Following discussion, **Mr. Rush moved to recommend to the full Board that the applicant be determined ineligible for a physician assistant license.** Factors contributing to this recommendation include previous action taken by the Texas Physician Assistant Board (TPAB); the applicant's involuntary termination from a position due to misconduct; a 2009 conviction for misdemeanor assault; and the applicant's time out of professional medicine since December 2011. **Mr. Cooper seconded the motion. All voted in favor. The motion passed.**  **Applicant #1230** appeared before the Committee, with the applicant's supervising physician and a colleague, after referral by the Executive Director. Following discussion, **Mr. Rush moved to recommend to the full Board that the applicant be granted a Texas physician assistant license. Dr. Reis seconded the motion. All voted in favor. The motion passed.** 

**Applicant #1619** was referred by the Executive Director and waived appearance before the Committee. Following discussion, **Mr. Cooper moved to recommend to the full Board that the applicant be granted a Texas Physician Assistant license under a non-disciplinary remedial plan with the following conditions:** 

- 4 Hours of Continuing Medical Education in Ethics
- 4 Hours of Continuing Medical Education in Professionalism

or in lieu of accepting the non-disciplinary remedial plan the applicant may choose to appear in person before the Licensure Committee at the next scheduled Board meeting. Factors contributing to this recommendation include the applicant's criminal history, action taken by a healthcare entity, the applicant's failure to report the action on the application for licensure. Mr. Rush seconded the motion. All voted in favor. The motion passed.

Agenda Item 3 - Discussion, recommendation, and possible action regarding review of Physician Assistant applications for permanent licensure. There were 330 applicants and 7 re-licensure applicants who met all requirements to be considered for permanent licensure by the full Board. Dr. Reis moved to recommend to the full board that all 330 applicants and 7 relicensure applicants be approved for permanent licensure. Mr. Rush seconded the motion. All voted in favor and the motion passed.

Agenda Item 4 – Proposed Orders Offered by the Executive Director – There were none

**Agenda Item 5 - Report on physician assistant licensure process statistics** – Ms. Knight reported that 749 PA licenses were issued in Fiscal Year 2014 and were completed in an average of 22 days. Ms. Knight also reported this is a 28% increase in physician assistants licensed in Fiscal Year 2014 from the previous year.

### Agenda Item 6 - Discussion, recommendation, and possible action regarding board rules:

a. §185.4 – Procedural Rules for Licensure Applicants

Mr. Rush moved to recommend to the full Board that the rule be published in the Texas Register as presented for public comment. Mr. Cooper seconded. All voted in favor. The motion passed.

Agenda Item 7 - Discussion, recommendation, and possible action regarding applicant packets. Mr. Freshour asked for direction from the committee regarding the release of application materials to applicants appearing before committee. Mr. Freshour explained that at this time applicants who appear before the committee only receive a copy of the committee summary and are not provided copies of the documentation the committee receives. The committee directed staff to make the recommended revisions to the evaluation (form L), to revise the letter sent to supervising physicians for supervised temporary licenses to clarify that the evaluations received by the Board will be released to the applicants if referred to the Licensure Committee, and to implement the release of committee packet materials to applicants appearing before committee.

Agenda Item 8- There being no further business, the meeting adjourned at 10:45 a.m.

## TEXAS MEDICAL BOARD RULES Texas Administrative Code, Title 22, Part 9 Proposed Changes

Chapter 185 Physician Assistants Page 1 of 1 Proposed for Publication

### 185.4. Procedural Rules for Licensure Applicants.

(a) –(g) Unchanged

(h) Re-Application for Licensure Prohibited. A person who has been determined ineligible for a license by the Licensure Committee may not reapply for a license prior to one year from the date of the Board's ratification of the Licensure Committee's determination of ineligibility and denial of licensure.
