## TEXAS MEDICAL BOARD MINUTES OF THE DISCIPLINARY PROCESS REVIEW COMMITTEE

August 30, 2012

Chair Melinda McMichael, M.D., called the meeting to order at 10:15a.m. Other members present were Julie K. Attebury, David Baucom, Patricia S. Blackwell, Manuel Guajardo, M.D., James Scott Holliday, D.O., Margaret C. McNeese, M.D., Stanley S. Wang, M.D., and Irvin E.Zeitler, Jr., D.O. Committee Member George Willeford III, M.D. arrived late at approximately 11:00a.m. and Committee Member Allan Shulkin, M.D. arrived late at approximately 11:46a.m.

Also present was Mari Robinson, Executive Director, Medical Director Robert Bredt, M.D., (arriving at 11:03am) and various other staff.

**Agenda Item #2.** Discussion, recommendation, and possible action regarding referrals and reports from the Texas Physician Health Program.

Dr. Nemeth discussed the different circumstances of eleven cases the Texas Physician Health Program is currently working and requested additional guidance on.

Dr. McNeese moved, and Dr. Wang seconded that PHP Case #11-0250 remain under the management of the PHP and to raise the testing levels of this respondent, if the raised testing levels is not agreed to, then the case will be returned to the jurisdiction of the Texas Medical Board. Motion carried.

Mr. Baucom moved, and Dr. Holliday seconded that PHP Case #12-0139 be returned to the jurisdiction of the Texas Medical Board and that the Respondent be scheduled for an ISC and that Dr. Nemeth be present at the ISC. Motion carried.

Dr. Zeitler moved, and Dr. Holliday seconded that PHP Case #11-0215 remain under the management of the PHP and that the request by the respondent to return to work on September 1, 2012, be granted. Motion carried.

Dr. Zeitler moved, and Ms. Blackwell seconded that PHP Case #12-0237 be returned to the jurisdiction of the Texas Medical Board and that the Respondent be scheduled for an ISC. Motion carried.

Dr. Zeitler moved, and Ms. Attebury seconded that Agenda Item 4.D & E. be accepted for publication with the following substitutions: 197.3.(b)(15) excludes the words implement and ensure all EMS personnel follow protocols that prohibit the back-signing of transfer orders; with the following substitution An Emergency Medical Director may not sign for any care or activity at the time they were not employed by the group, or words to that effect; and changes to 197.3.(b)(17) be clarified that the CME be in the area of EMS medical direction. Motion carried.

A lunch recess was taken at 12:20p.m., and the committee returned at 12:39p.m.

Dr. Zeitler moved, and Dr. Guajardo seconded; the motion passed at 12:49 p.m. to go into Executive Session deliberations concerning disciplinary action, investigative information, peer review information, and rehabilitation orders under the authority of The Medical Practice Act Sections 152.009, 160.006 through .008, 164.007(c), and 164.202 & .203, Occupations Code. Open session resumed at 2:55p.m., and it was announced that no action was taken during executive session. A certified agenda of the executive session was made. Ms. Robinson presented to the DPRC the current status of cases that are over one year old. To date, there are approximately 850 investigations that fall under this category; the majority being SOAH cases and pending expert panel review. This was an informational item only and no vote was necessary.

Dr. Zeitler moved, and Dr. Shulkin seconded; the motion passed at 3:26 p.m. to go into Executive Session deliberations concerning disciplinary action, investigative information, peer review information, and rehabilitation orders under the authority of The Medical Practice Act Sections 152.009, 160.006 through .008, 164.007(c), and 164.202 & .203, Occupations Code. Open session resumed at 4:12 p.m. and it was announced that no action was taken during executive session. A certified agenda of the executive session was made.

Dr. McNeese moved, and Dr. Zeitler seconded that the investigations and cases reviewed by the committee be resolved as noted and that they be listed along with each resolution as part of the minutes of this Committee. Motion carried.
