The temporary suspension of the Clinic's pain management certificate (without notice of hearing) was based upon the Board's determination that the continued operation of Spring Wellness Center as a pain management clinic poses a continuing threat to the public welfare. The Board found that the clinic was in violation of state laws that require a pain clinic to be owned and operated by a medical director who is a physician who practices in Texas with an unrestricted license; require the owner of the clinic to be on-site at least 33 percent of the clinic's operating hours; and require physician assistants to be supervised by a physician.</p> <p>On February 4, 2011, the Board and Jesus Caquias, M.D., the holder of the Pain Management Clinic Certificate for Spring Wellness Center, entered into an Agreed Voluntary Surrender Order in which Dr. Caquias voluntarily and permanently surrendered his certificate for operating the clinic, resolving the matter as it relates to Dr. Caquias's involvement in operating Spring Wellness Center.
