Laurel Coles

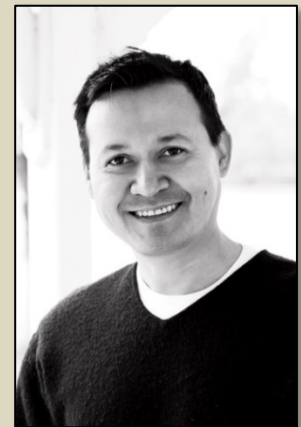

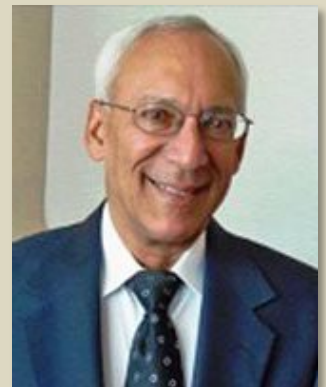
Zachary S. Jones, M.D.

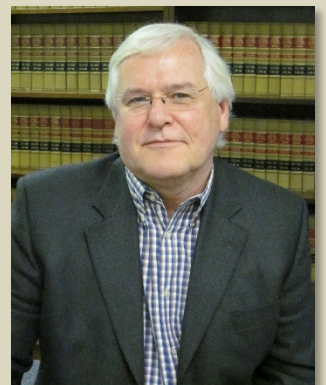
Ivan D. Rovner, M.D.

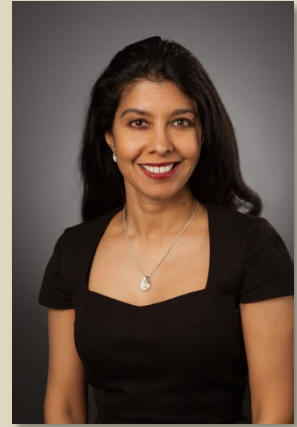
Celeste Caballero, M.D.
